QUESTION OF THE VIOLATION OF HUMAN RIGHTS IN THE OCCUPIED
ARAB TERRITORIES, INCLUDING PALESTINE

Note by the Secretary-General

1. In paragraph 16 of its resolution 1986/1 A, the Commission on Human Rights requested the Secretary-General to provide it with all United Nations reports appearing between sessions of the Commission and dealing with the situation of the population of the occupied Arab territories.
