## ANNEX

## Statement by the Government of the Mongolian People's Republic issued on 27 November 1986

The Administration of the United States of America has recently been engaging in dangerous escalation of the undeclared war against the sovereign independent Republic of Nicaragua.

The Reagan Administration has stepped up its financing and arming of the contras and the régimes of the countries bordering upon Nicaragua that go along with its policy, and is quiding events so as to provoke armed conflict in the region and use this as a pretext for direct military intervention against the Republic of Nicaragua for the purpose of overthrowing its lawful Government. Such actions are a flagrant violation of the principles of the Charter of the United Nations, of the Security Council resolutions on Nicaragua and of the decisions of the Non-Aligned Movement and the International Court of Justice. They seriously endanger international peace and universal security.

The Government of the Mongolian People's Republic and the entire Mongolian people strongly condemn the aggressive actions of the United States of America and call on it to put an immediate end to the undeclared war against Nicaragua. The Mongolian People's Republic again confirms its support for the constructive efforts of the Sandinist Government in the matter of easing tension and strengthening peace in Central America. It also supports the proposals of the Contadora Group and the Lima Support Group aimed at finding a peaceful solution to these urgent problems of the region.

The Government of the Mongolian People's Republic expresses its firm solidarity with the just struggle of the Nicaraguan people in defence of their revolutionary achievements and of the country's independence and sovereignty against the encroachments of United States imperialism and its accomplices. It calls upon all States and the United Nations to take effective measures aimed at preventing direct intervention by the United States of America in Nicaragua, removing the extremely dangerous hotbed of tension in Central America and the Caribbean and guaranteeing the right of the region's peoples to free and peaceful development.
