Note by the Secretary-General

- 1. As indicated in document A/41/102 of 18 February 1986, it will be necessary for the General Assembly, during its current session, to appoint six persons to fill vacancies in the membership of the Committee on Contributions resulting from the expiration, on 31 December 1986, of the terms of office of Mr. Leoncio Fernández Maroto, Mr. Lance L. - 2.
