Programme budget implications of draft resolution D recommended by
the Special Political Committee in its report (A/41/750, para. 26)

Report of the Fifth Committee

1. At its 38th meeting, on 28 November 1986, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statement by the Secretary-General (A/C.5/41/55) on the programme budget implications of draft resolution D recommended by the Special Political Committee in paragraph 26 of its report (A/41/750). The related report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman.
2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/41/SR.38).

DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 79 to 3, with 16 abstentions, to inform the General Assembly that, should it adopt draft resolution D recommended by the Special Political Committee in paragraph 26 of its report (A/41/750), an additional appropriation of \$200,000 would be required under section 23 of the programme budget for the biennium 1986-1987.

4. An additional appropriation of \$10,000 would also be required under section 31 (Staff assessment), offset by an increase of the same magnitude under Income section 1 (Income from staff assessment).

5. Conference-servicing requirements not exceeding an amount of \$454,400 would be considered in the context of the consolidated statement of conference-servicing requirements to be submitted to the General Assembly later in its current session. Should the General Assembly decide to authorize the Special Committee to hold a meeting in New York in December 1986 any actual additional expenditures that might be incurred would be reported in the context of the final performance report on the programme budget for the biennium 1986-1987.

6. The voting was as follows:

Against: Israel, Netherlands, United States of America.

Abstaining: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Federal Republic of, Iceland, Italy, Japan, New Zealand, Norway, Portugal, Spain, United Kingdom of Great Britain and Northern Ireland.
