APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF SUBSIDIARY BODIES OF THE GENERAL ASSEMBLY

Report of the Fifth Committee

Rapporteur: Mr. Brian J. LYNCH (New Zealand)

- 1. At its 1223rd meeting, on 12 December 1967, the Fifth Committee considered notes by the Secretary-General concerning the election by the General Assembly at the current session of three persons as members and three persons as alternate members of the United Nations Staff Pension Committee for three-year terms of office beginning on 1 January 1968.
- 2. The members of the Fifth Committee had previously been invited to propose the names of persons who might be recommended for the above appointments.

 Mr. J.I.M. Rhodes (United Kingdom of Great Britain and Northern Ireland),

 Mr. W.H. Ziehl (United States of America) and Mr. G. Valdes (Chile) had been nominated to fill the vacancies as members, and Mr. A.J. Cahen (Belgium),

 Mr. J.R. Kelso (Australia) and Mr. H.L. Morris (Liberia) had been proposed to fill the alternate member vacancies.
- 3. The Committee voted by secret ballot to decide on its recommendations. The results of the voting were as follows:
