Members of the Council have before them document S/2017/547, which contains the text of a draft resolution submitted by the Russian Federation and the United States of America.

I also wish to draw the Council's attention to document S/2017/486, which contains the report

of the Secretary-General on the United Nations Disengagement Observer Force for the period from 2 March to 16 May 2017.

The Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.
