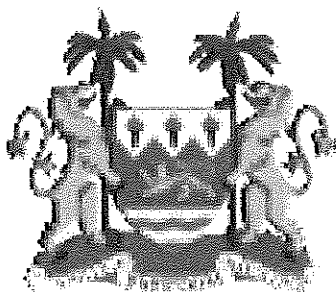

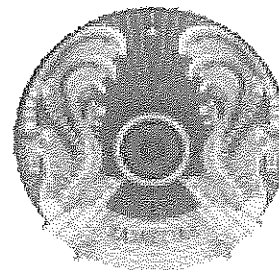

**JOINT COMMUNIQUE
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE REPUBLIC OF KAZAKHSTAN AND
THE REPUBLIC OF SIERRA LEONE**

The Republic of Kazakhstan and the Republic of Sierra Leone,

Desiring to reinforce and to develop mutually beneficial relations and cooperation between their countries and their peoples,

Guided by the purposes and principles enshrined in the Charter of the United Nations,

Have decided to establish diplomatic relations between the Republic of Kazakhstan and the Republic of Sierra Leone in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué

In witness thereof, the Undersigned Representatives, Duly authorized by their respective States, have signed this Joint Communiqué in duplicate in two original languages, Kazakh and English, both texts being equally authentic.

Executed in New York on 20 November, 2014.
