

ADDITIONAL MEASURES TO BE EMPLOYED TO MEET THE AGGRESSION IN KOREA

Reports from governments on measures taken in accordance with General Assembly resolution 500 (V) of 18 May 1951

CHILE

31 July 1951

I have the honour to inform Your Excellency that the Government of Chile has by Supreme Decree No. 467 of 23 July 1951, in accordance with the terms of the recommendation contained in resolution 500 (V) of the General Assembly, prohibited the export of all commodities of strategic value to Communist China and to North Korea.

27 July 1951

The Permanent Representative of Iceland to the United Nations presents his compliments to His Excellency the Secretary-General of the United Nations and, with reference to the resolution adopted by the General Assembly at its 330th plenary meeting on 18 May 1951, on additional measures to be employed to meet the aggression in Korea, has the honour to inform him that Iceland has no trade with areas under the control of the Central People's Government of the People's Republic of China or of the North Korean authorities. There is in existence in Iceland complete control of exports, and no trade will be initiated with the above areas.

Accordingly, it would be appreciated if the Secretary-General would inform the Additional Measures Committee that Iceland will co-operate with other countrie in implementing the above-mentioned resolution.

IRAQ

The Ministry for Foreign Affairs presents its compliments to the Secretary-General of the United Nations and, with reference to his telegram of June 15th 1951 concerning the measures taken to implement the General Assembly's resolution

of 18 May imposing the enbargo on the shipment of war materials and arms to the people's Republic of China, has the honour to inform him that the competent Iraqi authorities have taken all necessary steps within their power to make the embargo effective and to prevent any infringement and circumvention of the controls that have been applied.

THAILAND

31 July 1951

I have the honour to refer to my telegram sent to you through the Thai Permanent Delegation in New York, * reporting to the Additional Measures Committee on measures taken by His Majesty's Government in accordance with the strategic embargo resolution of 18 May adopted by the General Ascembly.

I have now the honour to inform you that, apart from the control over the export of certain commodities listed in my above-mentioned telegram and the prohibition on export of all arms and ammunition which had been in existence prior to the said resolution, His Majesty's Government has also issued a new Royal Decree placing under Government control the export of important materials as follows: tin ore, iron ore, wolfram or tungsten, antimony, lead metal, lead ore and zinc, para rubber, castor seeds, castor oil and kapok. The exportation from the Kingdom of any of the above items requires an export permit from the authorities and instructions have been given to the authorities issuing export permits to deny them in case of export to areas under the control of the Central People's Government of the People's Republic of China and of North Korean authorities.

In assuring Your Excellency that my Government will fully co-operate with other States in carrying out the purpose of the embargo, I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

PROCLAMATIONS BY HIS EXCELLENCY THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA

No. 154, 1951

PROHIBITION OF EXPORTATION OR CARRIAGE COASTWISE OF MUNITIONS

Under and by virtue of the powers vested in me by section one hundred and nineteen of the Customs Act, 1944 (Act No. 35 of 1944), I do hereby prohibit the exportation or the carriage coastwise to the places mentioned in the Schedule to this Proclamation of munitions and all such other goods as are mentioned in Government Notice No. 2065 of the 1st October, 1948, which I hereby deem to be capable of being converted into or used in the manufacture of munitions.

GOD SAVE THE KING.

Given under my Hand and Great Seal at Cape Town on this Eighteenth day of June, One thousand Nine hundred and Fifty-one.
