JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN

THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA AND THE INDEPENDENT STATE OF SAMOA

The Government of the Democratic Socialist Republic of Sri Lanka and the Government of the Independent State of Samoa;

Desirous to strengthen the relations of friendship and cooperation between the two countries in the political, economic and cultural fields, on the basis of the mutual observance of the principles of sovereignty, territorial integrity and non-interference with the internal matters of other countries;

Guided by the objectives and principles of the United Nations Charter and the Vienna Convention on Diplomatic Relations of April 18th 1961;

Have decided to establish diplomatic relations at the Ambassadorial level with effect from the date of signature of the present Joint Communiqué;

The Government of the Democratic Socialist Republic of Sri Lanka and the Government of the Independent State of Samoa are fully convinced that the establishment of diplomatic relations between the two States corresponds to their national interest and will strengthen international peace and cooperation.

In witness thereof, the undersigned Plenipotentiaries, duly authorized by their respective Governments, have signed the Joint Communiqué in English.
