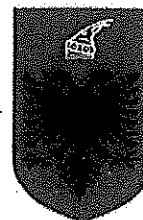

Desiring to promote and strengthen ties of friendship and cooperation between their countries and peoples on the basis of sovereign equality, mutual respect for each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of States,

Guided by the principles and purposes of the Charter of the United Nations, as well as the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963,

Convinced that the establishment of diplomatic relations corresponds to the interests of both States and will further strengthen international peace and security;

Have decided to establish diplomatic relations as of the date of the signing of this Joint Communiqué.
