**JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF
DIPLOMATIC RELATIONS
BETWEEN THE REPUBLIC OF KAZAKHSTAN
AND THE COMMONWEALTH OF DOMINICA**

The Republic of Kazakhstan and the Commonwealth of Dominica,

Guided by the principles enshrined in the Charter of the United Nations, International Law and the Vienna Convention on Diplomatic Relations of 18 April 1961, and being desirous of developing and strengthening relations of friendship and mutually beneficial cooperation between the two states,


Have decided to establish diplomatic relations at the Ambassadorial level, as of the date of the signing of this Joint Communiqué.

The Republic of Kazakhstan and the Commonwealth of Dominica are fully convinced that establishing diplomatic relations corresponds to the wishes of both States and will strengthen international peace and security.

In witness thereof, the undersigned representatives have signed this Joint Communiqué.
