Summary

1. Chapter I of this report provides details on the utilization of regular budget resources. Human resources were kept at maintenance level, whereas financial resources were increased by 9.37 per cent under section 20, Economic and Social Commission for Western Asia (ESCWA) and by approximately 1 per cent under section 21, Regular Programme of Technical Cooperation, in comparison with the biennium 1998-1999. Chapters II and III provide details of activities in support of regular programmes and technical assistance projects financed by United Nations programmes and funds as well as those financed by other national and regional donors, which decreased by 19 per cent in comparison with the previous biennium, in addition to the Trust Fund for ESCWA Regional Activities, which increased sevenfold.

I. REGULAR BUDGET

- 2. The regular budget of ESCWA is prepared and noted on a biennial basis in accordance with General Assembly resolution 3043 (XXVII) of 19 December 1972.
- 3. The revised appropriations approved by the General Assembly in its document on the programme budget for the biennium 2000-2001, under section 20, Economic and Social Commission for Western Asia, amounted to US\$ 45,698,200.

Allocation of resources

- 4. For the biennium 2000-2001, the General Assembly approved a total of 103 Professional and 163 General Service posts for ESCWA.
- 5. The allotments, expenditures and balances for the biennium 2000-2001 are broken down by subprogramme in the remainder of chapter I.

Chart 2. General Service staff members, by division






Chart 3. Comparative distribution of staff members, by division



II. EXTRABUDGETARY RESOURCES

A. INTRODUCTION

- 8. This chapter on the financial status of the extrabudgetary resources of ESCWA covers the biennium 2000-2001, which ended on 31 December 2001. The accounts reported on relate to all extrabudgetary resources from different contributors in support of activities financed from the regular budget. After a brief overview of the activities and financial situation of the Commission as a whole, the remaining sections provide financial information relating to the major sources of extrabudgetary funds. Excluding the Trust Fund for ESCWA Regional Activities, the Government of France and the Government of the Netherlands, these resources amounted to US\$ 2,748,498 (see annex I).
- 9. Extrabudgetary resources for the Trust Fund for ESCWA Regional Activities, the Government of France and the Government of the Netherlands during the biennium 2000-2001 amounted to US\$ 214,461. Annex II shows the combined status of trust funds for the biennium 2000-2001.

B. OVERVIEW

- 10. The major sources of extrabudgetary funds for the biennium 2000-2001 were the United Nations Development Programme (UNDP), the United Nations Population Fund (UNFPA) and the Arab Gulf Programme for United Nations Development Organizations (AGFUND).
- 11. It should be noted that the Commission will continue its efforts to raise voluntary contributions for extrabudgetary financing of the programme of work and of studies or advisory services requested by member States.

C. HISTORY OF ACTIVITIES

1. United Nations Development Programme

- 12. The financial support of UNDP for ESCWA activities dates from 1979. The contributions have been utilized to finance projects in the fields of planning and training; finance and banking; natural resources; industry; social statistics, surveys and censuses; and transport, communications and maritime activities.
- 13. During the biennium 2000-2001, contributions of US\$ 972,766 from UNDP were utilized to finance the following activities in the ESCWA region:
 - (a) Development of national gender statistics programme in the Arab countries: US\$ 126,837;
- (b) Integrated regional follow-up by the Arab States to United Nations global conferences: US\$ 273,841;
- (c) National environmental strategy and environmental action for the United Arab Emirates: US\$ 427,342;
 - (d) National programme for promoting sustainable development at the institutional level: US\$ 21,734;
 - (e) ESCWA assistance to UNDP Jordan: US\$ 95,962;
 - (f) National Human Development Report for Iraq: US\$ 27,050.
 - 2. United Nations Development Programme, ESCWA as cooperating agency for UNDP
- 14. Support for the Yemen National Poverty Eradication Programme amounted to US\$ 278,834.


- 15. Contributions from UNFPA to ESCWA activities started in 1975. During the biennium 2000-2001, contributions of US\$ 843,072 from UNFPA were utilized to finance activities in the ESCWA region related to population and demography, as follows:
 - (a) Population Policies Information System (PPIS): US\$ 85,783;
 - (b) Technical support services: US\$ 757,289.
 - 4. Arab Gulf Programme for United Nations Development Organizations
- 16. Contributions from AGFUND to ESCWA started in 1989 and have been utilized for regional household surveys, Arab community development and the participation of women in such development. During the biennium 2000-2001, US\$ 252,180 were utilized to finance the following projects and activities:
 - (a) Regional household survey project: US\$ 20,954;
 - (b) Arab rural community development phase II Egypt and the Syrian Arab Republic: US\$ 21,317;
 - (c) Arab rural community development Lebanon: US\$ 60,971;
- (d) Training and rehabilitation in community development in Egypt, Jordan, Kuwait, Lebanon, Palestine and the Syrian Arab Republic: US\$ 43,020;
- (e) Participation of Women in Community Development in ESCWA Rural Areas Syrian Arab Republic: US\$ 28,842;
- (f) Expansion of the Braille computer training for the blind in Lebanon and the Arab region: US\$ 31,900;
 - (g) Database on Palestinian refugees during 1998/2000 in Syria and Lebanon/Palestine: US\$ 45,176.

III. TRUST FUND FOR ESCWA REGIONAL ACTIVITIES

A. BACKGROUND

- 17. In its review of the programme of work at its second session, the Commission noted that the level of resources provided by the regular programme budget was inadequate to meet the programme needs, particularly for the great number of projects requested for the region. Extrabudgetary resources were therefore required for the successful implementation of the Commission's programme of work. In the operative paragraph of its resolution 11 (II) of 9 May 1975 on the Voluntary Fund, the Commission decided to authorize the Chairman of the second session and the Executive Secretary to hold urgent consultations with member States with a view to exploring the best and speediest ways of establishing an additional fund financed from voluntary contributions for the extrabudgetary financing of the Commission's work programmes and for meeting requests by member States for studies and advisory services.
- 18. In paragraphs 1 and 2 of its resolution 33 (III) of 14 May 1976 on the establishment of a voluntary fund, the Commission decided to establish a voluntary fund and called upon the Executive Secretary to utilize the resources of the fund to finance the greatest possible number of services in the fields of economic and social development in favour of the least developed ESCWA member countries.
- 19. At its fourth session, in paragraph 2 of its resolution 45 (IV) of 28 April 1977 on the financial status of the Commission's programmes and the strengthening of the Voluntary Fund, the Commission urged member States to make voluntary contributions towards the general financing of its programmes or the financing of specific projects. In paragraph 4 of that resolution, the Commission called upon the Executive Secretary to submit a financial statement of the Voluntary Fund for its approval at each session. Chapter three of this report and annex II thereto are in response to that request.
- 20. In paragraph 3 of its resolution 45 (IV), the Commission requested the Executive Secretary to invite member States of the Commission six months before the date scheduled for the holding of each session to determine the amount of their contributions towards the resources of the Fund. In paragraph 1 of its resolution 236 (XXI), the Commission decided to hold a pledging conference during each session of the Commission, the first of which will be held during the twenty-second session.

B. CONTRIBUTIONS

21. In response to resolution 33 (III), the Voluntary Fund (subsequently named the Trust Fund for ESCWA Regional Activities) was established by the Secretary-General. The contributions amounted to a total of US\$ 2,433,485. The status of contributions received from 1975 to 31 December 2001 is presented below.

To this effect, the Government of Kuwait contributed an amount of US\$ 500,000 and the Government of Lebanon contributed an amount of US\$ 1,000,000. During the biennium 2000-2001, the Governments of Kuwait and Lebanon approved the request of the Commission to redirect the amount of US\$ 109,621 from the original contribution of US\$ 1,500,000, for the purpose of financing ESCWA regional activities in the fields of economic and social development.

22. In accordance with the procedure established by the Secretary-General and approved by the General Assembly, an annual pledging conference is held at United Nations Headquarters in New York, during which all States Members of the United Nations are requested to announce their contributions to all programmes and funds established by the United Nations, including the Trust Fund for ESCWA Regional Activities. A detailed account of ESCWA extrabudgetary resources excluding the Trust Fund is contained in chapter II of this report.

C. PROGRAMME OF ACTIVITIES FINANCED FROM THE TRUST FUND

23. At its second session, the Commission, in its resolution 11 (II) of 9 May 1975, decided to explore ways of establishing a voluntary fund to serve as a source of revenue for the extrabudgetary financing of the Commission's programme of work and for meeting requests by member States for studies and advisory services. At its third session, the Commission in paragraph 2 of its resolution 33 (III) of 14 May 1976, circumscribed the utilization of the resources of the Fund to the various fields of economic and social development in favour of the least developed ESCWA member countries. At its seventh session, in its resolution 79 (VII) of 22 April 1980 on the strengthening of the Financial Contributions Account of the Economic Commission for Western Asia, the Commission expanded the area of activities to be financed from the resources of the Fund to include surveys and statistical research, analytical studies, training, consultant services and all economic and social sectors and subsectors.

24. During the biennium 2000-2001, US\$ 209,283 were utilized for the following activities:


