**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE UNION OF MYANMAR
AND
THE REPUBLIC OF BELARUS**

The Union of Myanmar and the Republic of Belarus, guided by the principles enunciated in the Charter of the United Nations and being desirous to establish relations of friendship and mutually beneficial cooperation on the basis of the principles of equality, non-interference in the internal affairs of the others, respect for independence and territorial integrity, have decided to establish diplomatic relations between the two countries at Ambassadorial level as of the date of the signing of this Joint Communiqué, in duplicate, each copy in English and Belarusian languages, all texts being equally authentic.
