REPORT ON THE STATE OF PREPAREDNESS OF DOCUMENTS FOR THE SIXTEENTH SESSION

- 1. The General Assembly, in resolution 33/56, decided that eight weeks before the opening meeting of an intergovernmental body, a report on "the state of preparedness of all documents for the session, in all languages" should be circulated.
- 2. In compliance with that resolution, the following table shows the state of preparedness on 25 March 1991 of documents for the sixteenth session of the Governing Council. For documents which have been distributed in all six language versions, it indicates the date of issue. For the remaining documents it gives the scheduled dates of distribution. It should be noted that Monday, 8 April 1991 is the date by which documents are to be distributed in compliance with the six-week rule Rule 12, para. 3 of the Rules of Procedure of the Governing Council).
