NEW SOUTH WALES REGULATION (1955-No. 205)

POLICE OFFENCES (AMENDMENT) ACT, 1908, as amended (Published in Government Gazette No. 105 of 23rd September, 1955)

HIS Excellency the Governor, with the advice of the Executive Council, has been pleased to amend, in the manner set forth hereunder, the Regulations under the Police Offences (Amendment) Act, 1908, as amended.

Regulation 17 is amended by omitting sub-paragraph (a) of paragraph (2) and by inserting in lieu thereof the following sub-paragraph:-

- (a) He shall write such prescription in ink and shall in his own handwriting place on such prescription-
 - (i) the date on which it is written;
 - (ii) the name and address of the person for whom it is given;
 - (iii) the maximum number of times and the intervals at which it shall be dispensed.

and sign such prescription. The prescription shall bear the address of such Medical Practitioner or Veterinary Surgeon.

The Regulations under the Police Offences (Amendment) Act, 1908, as amended by subsequent Acts, are amended:

- (a) by inserting in paragraph (1) of Regulation 11 after the word "transaction" the words "Each such entry shall, inter alia, in the column provided in the register for the particular purpose-
 - (a) show the balance of the drug held by the holder of a license or other authorised person, at the premises where the register is kept, after the transaction to which the entry relates.
 - (b) be signed, on the day the entry is made, by the actual dispenser or administrator of the drug".
- (b) by omitting Regulations 12 and 13 and the heading thereto;
- (c) by omitting the words "(One only, irrespective of strength, to page)" in Schedule 5 and inserting in lieu thereof the words "(One drug, of one trade name and one strength only to page)".

SOUTH AUSTRALIA

No. 31 of 1955

An Act to amend the Dangerous Drugs Act, 1934 (Assented to 1st December, 1955)

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles

- 1. (1) This Act may be cited as the "Dangerous Drugs Act Amendment Act, 1955.
- (2) The Dangerous Drugs Act, 1934, as amended by this Act, may be cited as the Dangerous Drugs Act, 1934-1955".
 - (3) The Dangerous Drugs Act, 1934, is hereinafter referred to as "the principal Act".

Incorporation

Act applies.

s. 4,-Drugs to which 2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

Amendment of

3. (1) Section 4 of the principal Act is amended -

principal Act

- (a) by striking out subsection (3) thereof and inserting the following subsection in its place;
 - (3) If it appears to the Governor that -
 - (a) any derivative of morphine or cocaine or of any salts of morphine or cocaine; or
 - (b) any other alkaloid of opium; or
 - (c) any other drug or substance of whatever kind,

to which this Act does not apply, is or is likely to be productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be, productive, if improperly used, of ill-effects substantially of the same character or nature as or analogous to those produced by morphine, cocaine or Indian hemp, the Governor may by proclamation declare that this Act shall apply to that derivative, alkaloid, or other drug or substance.

- (i) in the same manner as it applies to the drugs mentioned in subsection (1) of this section.
- (ii) with such modifications as may be specified in the proclamation.
- (b) by striking out subsection (5) thereof.
- (2) Any proclamation made pursuant to subsection (3) or subsection (5) of section 4 of the principal Act before the commencement of this Act shall be deemed to have been made under subsection (3) of section 4 of the principal Act as enacted by subsection (1) of this section.

Amendment of principal Act s. 5 -Pendities

- 4. Section 5 of the principal Act is amended -
- (a) by inserting after the word "supplied" in the first line of paragraph (c) of subsection (2) thereof the words "in compliance with the regulations";
- (b) by inserting at the end of paragraph (c) of subsection (2) thereof the words "and was obtained by him in compliance with the regulations;
- (c) by striking out subsection (3) thereof and inserting in its place the following subsection:
 - (3) Any person who grows or cultivates
 - (a) the opium poppy (papaver somniferum L.); or
- (b) any plant of any genus of the erythroxylaceae, from the leaves of which cocaine can be extracted either directly or by chemical transformation; or
 - (c) the pistillate plant known as cannabis sativa L.,

shall be guilty of an offence against this Act: Provided that this subsection shall not apply to any plant grown or cultivated or caused to be grown or cultivated by the Governors of the Botanic Garden.

Enactment of s. 6a of principal Act Prohibition of drugs

- 5. The following section is enacted and inserted in the principal Act after section 6 thereof:
 - 6a (1) The Governor may by proclamation declare any drug to which this Act applies to be a prohibited drug.
 - (2) Notwithstanding any other provision of this Act, a person who sells, trades in, manufactures, conveys in any manner, or has in his possession any prohibited drug except in compliance with such conditions (if any) as are mentioned in the proclamation declaring the drug to be a prohibited drug shall be guilty of an offence against this Act.
- 6. Section 7 of the principal Act is amended by inserting after the word "board" at the end of the fourth paragraph in subsection (2) thereof the words "and may provide that any licence or authority so withdrawn may be re-issued or re-granted by the Minister on the recommendation of the board".
- 7. Section 10 of the principal Act is amended by inserting after the word "any" in the second line thereof the words "legally qualified medical practitioner, veterinary surgeon qualified in accordance with the regulations".
- 8. Section 12 of the principal Act is amended by adding at the end thereof the following subsection (the preceding portion of section 12 being read as subsection (1) thereof):
- (2) The member of the police ferce or the person employed in the public service may do any or more of the following things:-
 - (a) seize and carry away any such books or documents or stocks;
 - (b) seize and carry away any substance found on the premises, which he has reasonable cause to believe to be or to contain any drug to which this Act applies:
 - (c) take and carry away samples of any such substance.

Dihydrohydroxymorphinone, Oxymorphone 7 its salts and all preparations thereof.

4.4-diphenyl-6-dimethylamino-3-hexanone Normethadone, its salts and all preparations thereof.

Amendment of principal Act, s. 7. Regulations.

Amendment of principal Act s. 10 Obtaining drugs by faise pretence Amendment of principal Act s. 12 Power to enter And declare that Division 2 of Part III, of the Poisons Act 1928 as amended by the Poisons Act 1930 shall apply to the substances and preparations named herein in the same manner as it applied to substances or preparations mentioned in the said paragraph (1) of the Sixth Schedule and the provisions of the said division shall apply accordingly.

South Australia Proclamation by His Excellency the Lieutenant-Governor of the State of South Australia to wit

BY virtue of the provisions of the Dangerous Drugs Act, 1934, and all other enabling powers, I, the said Lieutenant Governor-, with the advice and consent of the Executive Council, do hereby -

- 1. Declare that subsection (1) of section 6 of the said Act shall cease to apply to-
- (1) Dihydrohydroxymorphinone Oxymorphone and its salts.
- (2) 6-Methyldihydromorphine Methyldihydromorphine and its salts.
- 2. Declare that the said Act shall apply to the drugs specified in the schedule hereto in the same manner as it applies to the drugs mentioned in subsection (1) of section 4 thereof.

THE SCHEDULE

- (1) Dihydrohydroxymorphinone and its salts.
- (2) 6-Methyldihydromorphine and its salts.
- (3) Isopropyl Properidine and other esters of 1-methyl-4-phenyl-piperidine-4-carboxylic acid and their salts.
- (4) 4, 4-diphenyl-6-dimethylamino-3-hexanone Normethadone and its salts.
- (5) \$\begin{align*} & -4.4 \text{diphenyl-6-dimethylamino-3-heptanol} & -6 \text{dimethylamino-4.4-diphenyl-3-heptanol} & \text{(Beta-methadol)} and its salts.
- (6) 4,4 diphenyl-6-piperidine-3-heptanone Dipipanone and its salts.
- (7) Any preparation, admixture, extract, or other substance containing any proportion of any of the substances mentioned in this schedule.

POISONS AND DANGEROUS DRUGS ORDINANCE 1933-1954

Notice Declaring Certain Drugs, Chemicals And Compounds to be Narcotic Drugs. Commonwealth of Australia Gazette, No. 20, dated 5th May, 1955.

WHEREAS by section twelve of the Poisons and Dangerous Drugs Ordinance 1933-1954 it is provided (inter alia) that the Minister of State for Health may, by notice in the Gazette, declare what drugs, chemicals or compounds are, for the purposes of the Ordinance, narcotic drugs:

And whereas by notice published in the Gazette on the twenty eighth day of May, One thousand nine hundred and thirty-three, certain drugs, chemicals and compounds were declared to be, for the purposes of the Poisons and Dangerous Drugs Ordinance 1933-1938, narcotic drugs:

And whereas it is desirable to revoke the said declaration and to make other provision in lieu thereof: Now therefore I. Earle Page, the Minister of State for Health, do hereby -

- (a) revoke the said declaration; and
- (b) declare that the drugs, chemicals and compounds specified in the Schedule to this notice are, for the purposes of the Poisons and Dangerous Drugs Ordinance 1933-1954, narcotic drugs.
