#### Dangerous Drugs Act, 1936

# DANGEROUS DRUGS ACT (APPLICATION) ORDER NO. 2, 1954

WHEREAS by subsection (2) of section 10 of the Dangerous Drugs Act, 1936, power is conferred on the Governor by Order in Executive Committee to declare that Part IV of that Act shall apply to any drug of whatever kind in the same manner as it applies to the drugs mentioned in subsection (1) of section 10 of the Act if it appears to him that the drug is, or is likely to be productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be productive if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

AND WHEREAS it appears to the Governor that the drugs specified in the First Schedule to this Order are productive, if improperly used, or are capable of being converted into substances which are, or are likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

AND WHEREAS the Governor has by certain Orders in Executive Committee made under the said subsection (2) declared that the said Part IV should apply to, amongst other drugs, the drugs specified in the Second Schedule to this Order:

AND WHEREAS it is expedient that the said Part IV should no longer apply to the drugs specified in the said Second Schedule.

NOW, THEREFORE, the Governor-in-Executive Committee in exercise of the powers conferred upon him by subsection (2) of section 10 of the Dangerous Drugs Act, 1936, and all other powers him enabling, hereby makes the following Order:-

1. This Order may be cited as the Dangerous Drugs Act (Application) Order No. 2, 1954. 2. Part IV of the Dangerous Drugs Act, 1936 (which provides that it shall not be lawful to import or export any Drug to which that Part applies except in accordance with Part V of that Act and empowers the Governor-in-Executive Committee to make regulations for preventing the improper use of such drugs) shall apply to the drugs specified in the First Schedule to this Order in the same manner as the said Part IV applies to the drugs mentioned in subsection (1) of section 10 of that Act.

3. Part IV of the Dangerous Drugs Act, 1936, shall cease to apply to the drugs specified in the Second Schedule to this Order, and accordingly-

- (a) in the Schedule to the Dangerous Drugs Act (Application) Order 1951 (which specifies the drugs to which Part IV of the Dangerous Drugs Act, 1936, is applied by the Order, which drugs include methorphinan, its salts and other substances containing any proportion thereof) after the said word "Methorphinan", in both places where it occurs, there shall be added the words "other than dextrorphan";
- (b) in the Schedule to the Dangerous Drugs Act (Application) Order 1954 (which specifies the drugs to which the said Part IV is applied by the Order, that is to say 3-methoxy-N-Methylmorphinan, its salts and other substances containing any proportion thereof), for the words "3-methoxy-N-methylmorphinan (that is to say, dextromethorphan, levomethorphan and racemethorphan)" there shall be substituted the word "3-Methoxy-N-methylmorphinan other than dextromethorphan (that is to say laevomethorphan and racemethorphan)."

#### FIRST SCHEDULE

Any preparation, admixture or other substance (except syrupus Codeinae Phosphatis B.P.C. 1934 or 1949) containing any proportion of methylmorphine (also known as codeine) or ethylmorphine (also known as dionin) associated with any inert substance whether solid or liquid, and any preparation, admixture or other substance containing more than 2.5 per cent. of methylmorphine or ethylmorphine (calculated as pure drug) associated with any other medicinal substance.

All preparations of esters of ecgonine or of their respective salts and all preparations of ecgonine containing less than one-tenth per cent. of ecgonine and all preparations of esters of morphine.

Methyldihydromorphinone (also known as metopon), its salts and any preparation, admixture, extract or other substance containing any proportion of methyldihydromorphinone.

Alphameprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of alphameprodine.

Betameprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of betameprodine.

Dihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrocodeine.

Methyldesomorphine (6-methyl- $\triangle$ <sup>6</sup>-desoxymorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of methyldesomorphine or its salts.

#### SECOND SCHEDULE

The isomer of methorphinan known as dextrorphan, its salts and any preparation, admixture, extract or other substance containing any proportion of dextrorphan.

The isomer of 3-methoxy-N-Methylmorphinan known as dextromethorphan, its salts, and any preparation, admixture, extract or other substance containing any proportion of dextromethorphan.

#### Dangerous Drugs Act, 1936

#### DANGEROUS DRUGS ACT (RELAXATION) ORDER, 1955

WHEREAS by subsection (1) of section 11 of the Dangerous Drugs Act, 1936, it is provided that it shall not be lawful for any person to trade in or manufacture for the purpose of trade any products obtained from any of the phenanthrene alkaloids of opium or from the ecgonine alkaloids of the coca leaf, not being a product which was on the thirteenth day of July, one thousand nine hundred and thirtyone, being used for medical or scientific purposes, and that the Governor may, if satisfied as respects any such product that it is of medical or scientific value, by Order direct that the subsection shall cease to apply to that product: AND WHEREAS the Governor is satisfied that the drugs specified in the Schedule to this order, being products obtained from morphine, one of the phenanthrene alkaloids of opium, which were not on the said date being used for medical or scientific purposes, are of medical value:

NOW, THEREFORE, the Governor in exercise of the power conferred upon him by section (1) of section 11 of the Dangerous Drugs Act, 1936, hereby makes the following Order:-

1. This Order may be cited as the Dangerous Drugs Act (Relaxation) Order, 1955.

2. Subsection (1) of section 11 of the Dangerous Drugs Act, 1936, shall cease to apply to the drugs specified in the Schedule to this Order.

1. This Order may be cited as the Dangerous Drugs Act (Application) Order, 1955.

2. Part IV of the Dangerous Drugs Act, 1936, (which provides that it shall not be lawful to import or export any drug to which that Part applies except in accordance with Part V of the Act and empowers the Governor-in-Executive Committee to make regulations for preventing the improper use of such drugs shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part IV applies to the drugs mentioned in subsection (1) of section ten of the Act.

Diethylthiambutene (3-diethylamino-1: 1-di (2' thienyl)-1-butene), its salts and any preparation, admixture, extract or other substance containing any proportion of diethylthiambutene.

1-Methyl-4-phenylpiperidine-4-carboxylic acid isopropyl ester, its salts and any preparation, admixture, extract or other substance containing any proportion of 1-methyl-4-phenylpiperidine-4carboxylic acid isopropyl ester.

Normethadone (4: 4-diphenyl-6-dimethylamino-3-hexanone), its salts and any preparation, admixture, extract or other substance containing any proportion of normethadone.
