PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1981 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL.—In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

REGULATION NO. 1 of 13 FEBRUARY 1962

The Director of the National Medical and Pharmaceutical Control Service of the Ministry of Health, in the exercise of the powers vested in him by article 29, section XI, of the regulations approved by Decree No. 41,904 of 29 July 1957, read in conjunction with Decree No. 891 of 25 November 1938 and on the express recommendation of the National Commission for the Control of Narcotic Drugs,

HEREBY DECIDES:

- (a) to include the substances "methadone" and "normethadone" and their derivatives in Tables A (2nd group) and B of pharmaceutical substances and proprietary drugs;
- (b) that, for the purposes of the control of the aforesaid substances, all pharmaceutical establishments shall enter deliveries of these substances in the official book of the Register of Narcotic Drugs;
- (c) this Regulation shall come into force on the date of its publication.

REGULATION NO. 26 OF 1 OCTOBER 1962

The Director of the National Medical and Pharmaceutical Control Service, in the exercise of the powers vested in him by article 29, section XI, of the regulations approved by Decree No. 41,904 of 29 July 1957, and by virtue of article 1, paragraph 3, of Decree No. 891 of 25 November 1938 and of article 60 (d) of Decree No. 49,974 A^{2} of 21 January 1961, which supplements the National Health Code,

Considering the decision taken by the National Commission for the Control of Narcotic Drugs at its meeting of 12 July 1962, on the basis of the statement made by the National Medical and Pharmaceutical Control Service;

Considering that papaverine and its salts, including its synthetic salts, are no longer classified as narcotic drugs by the international instruments relating to narcotic drugs, HEREBY DECIDES:

to declare inoperative Regulation No. 103 of 27 December 1945, published in the "Diário Oficial" of 12 January 1946, with the consequence that papaverine and its salts, including its synthetic salts, will be excluded from the second group of article 1 of Decree No. 891 of 25 November 1938 and the corresponding general instructions concerning the use and sale of narcotic drugs.
