## BRITISH HONDURAS No. 13 of 1947.

An Ordinance relating to the admissibility of evidence in proceedings under the Dangerous Drugs Ordinance, 1928; (No. 22 of 1928).

[28th June, 1947]

Be it enacted by the Governor of British Handuras, with the advice and consent of the Legislative Council thereof:

- 1. This Ordinance may be cited as the Dangerous Drugs (Amendment) Ordinance, 1947.
- 2. The Dangerous Drugs Ordinance, 1928, is hereby amended by the addition thereto, immediately after section 15, of the following section: "Evidence. 15A. (1) In any proceedings for an offence against this Ordinance-
  - (a) the production of a certificate signed by the Island Chemist or Deputy Island Chemist of the Colony of Jamaica (hereinafter referred to as the "Chemist") shall be sufficient evidence of all the facts therein stated, unless the defendant requires that the Chemist be called as a witness, in which case the Court shall take such steps as may be necessary to secure the attendance of the Chemist as a witness.
  - (b) no proof need be given of the signature or official character of the Chemist.
- (2) Where the Chemist is called as a witness the defendant shall, if convicted, be ordered to pay, in addition to the penalty imposed upon him, all costs occasioned by the Chemist having been so called.

An Ordinance to amend the Dangerous Drugs Ordinance, 1928, (No. 22 of 1928), by the deletion of the provision (in Ordinance No. 13 of 1947) relating to payment of certain costs.

Be it enacted by the Governor of British Honduras, with the advice and consent of the Legislative Council thereof:

- 1. This Ordinance may be cited as the Dangerous Drugs (Amendment) Ordinance, 1948.
- 2. Section 15A of the Dangerous Drugs Ordinance, 1928, added by the Dangerous Drugs (Amendment) Ordinance, 1947, (No. 13 of 1947), is hereby amended as follows-
  - (a) by the repeal of subsection (2) thereof;
  - (b) by the renumbering of section "15A. (1)" as section "15A.".
