PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL.—In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

ORDER NO. 2772 OF 19 APRIL 1955

PROMULGATING ARTICLE 6 OF THE ACT No. 53-1270 OF 24 DECEMBER 1953

AMENDING AND COMPLETING THE LEGISLATIVE PROVISIONS RELATING TO THE SUPPRESSION OF ILLICIT TRAFFIC IN AND USE OF NARCOTIC DRUGS

The High Commissioner of the French Republic in the Cameroons makes the following Order, in virtue of:

The Decrees of 23 March 1921 and 21 February 1925 determining the attributions of the Commissioner of the French Republic in the Cameroons and the Decree of 13 February 1937;

The Decree of 16 April 1924 determining the manner of promulgation and publication of the regulating texts in the Cameroons;

The Decree of 9 October 1926 regulating the trade in, possession and use of poisonous substances promulgated by the Order of 27 November 1956;

The Ministerial Circular of 10 September 1931 relating to the promulgation and publication in the Colonies of certain legislative and regulating texts;

The Decree of 9 November 1937 to introduce public administrative regulations to give effect to the Act of 12 July 1916 concerning trade in poisonous substances promulgated by the Order of 10 July 1938;

The Ministerial despatch No. 05170/DSS/3 of 14 June 1954.

Article 1. - The following text is hereby promulgated in the Cameroons: "Article 6 of Act No. 53-1270 of 24 September 1953 applying in the Overseas Territories, Togoland and the Cameroons the provisions of chapter 1 of Section III of the Pharmacy Code ²⁾ (J.O.R.F. of 25 September 1953, page 11535).

Article 2. - This Order shall be registered, communicated and published wherever required.
