Law 3 of 1967

NARCOTIC DRUGS ORDER, 1973

Order under section 13.

Whereas it appears to the Council of Ministers that the decisions of the Commission on Narcotic Drugs of the Economic and Social Council of the United Nations to alter Schedules I, II and III of the Single Convention on Narcotic Drugs, 1961, signed at New York on 30 March 1961, by the addition to the said Schedules of certain substances requires the addition of those substances to Parts I and II of the Schedule to the Narcotic Drugs Law, 1967:

Now therefore, the Minister of Health in exercise of the powers vested in the Council of Ministers by section 13 of the Narcotic Drugs Law, 1967, which were delegated to him by the Council of Ministers, hereby orders as follows:

- 1. This Order may be cited as the Narcotic Drugs Order, 1973.
- 2. Paragraph 1 of Part I of the Schedule to the hereinbefore mentioned Law is hereby amended by the insertion therein of the word "Drotebanol" 2/ immediately after the word "dipipanone".

- 3. Part II of the Schedule to the hereinbefore mentioned Law is hereby amended as follows:
  - (a) by the insertion of the word "nicodicodine" immediately after the word "pholcodine" (sub-paragraph (2) of paragraph 9);
  - (b) by the substitutions for paragraph 12 of the following paragraph:
    - "12. Preparations of <u>diphenoxylate</u> containing, per dosage unit, not more than 2.5 mg of diphenoxylate calculated as a base, and a quantity of atropine sulphate equivalent to at least one per cent, of the dose of diphenoxylate".

NARCOTIC DRUGS (AMENDMENT) REGULATIONS, 1973

Regulations made under sections 6 and 16.

3 of 1967 The Council of Ministers in exercise of the powers vested in it by sections 6 and 16 of the Narcotic Drugs Law, 1967, hereby makes the following Regulations:

- 1. These Regulations may be cited as the Narcotic Drugs (Amendment) Regulations, 1973, and shall be read as one with the Narcotic Drugs Regulations, 1967, 3/ (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may be cited as the Narcotic Drugs Regulations 1967 to 1973.
- 2. Paragraph 1 of the Second Schedule to the principal Regulations is hereby amended by the insertion therein of the word "Nicodicodine" immediately after the word "pholcodine".
