PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

CYPRUS

Communicated by the Government of the United Kingdom of Great Britain and Northern Ireland

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

THE DANGEROUS DRUGS LAW. CAP. 73 and Law 39 of 1953.

ORDER IN COUNCIL No. 2788 made under Section 12 (2).

Whereas from time to time various Orders in Council have been made under sub-section (2) of section 12 of the Dangerous Drugs Law, declaring that Part III of the said Law should apply to the drugs specified in the Orders in Council in the same manner as it applies to the drugs mentioned in sub-section (I) of the said section 12:

And whereas certain of the aforesaid Orders in Council are spent, and it is expedient that they should be revoked, and it is expedient that the provisions of the remaining Orders in Council aforesaid should be consolidated:

And whereas it appears to the Governor-in-Council that certain drugs, in addition to those drugs specified in the Orders in Council aforesaid, are productive, if improperly used, or are capable of being converted into a substance, which is, or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine:

Now, therefore, in exercise of the powers vested in him by sub-section (2) of section 12 of the Dangerous Drugs Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and declare as follows:-

- 1. This Order may be cited as the Dangerous Drugs (Application of Law) Order, 1955.
- 2. Part III of the Dangerous Drugs Law (which provides that it shall not be lawful to import or export any drug to which that Part applies except under licence, and empowers the Governor-in-Council to make regulations for the purpose of preventing the improper use of such drugs), shall apply to the drugs specified in the First Schedule to this Order in the same manner as the said Part III applies to the drugs mentioned in sub-section (I) of section 12 of that Law.
- 3. The Orders in Council specified in the Second Schedule to this Order are hereby revoked.

First Schedule. (Clause 2).

DRUGS TO WHICH PART III OF THE DANGEROUS DRUGS LAW IS APPLIED BY THIS ORDER.

- 1. Any preparation, admixture or other substance (except syrupus Codeinae Phosphatis B.P.C. 1949 or 1954) containing any proportion of methylmorphine (also known as codeine) or ethylmorphine (also known as dionin) associated with any inert substance whether solid or liquid, and any preparation, admixture or other substance containing more than 2.5 per cent. of methylmorphine or ethylmorphine (calculated as pure drug) associated with other medicinal substance.
- 2. All preparations of esters of ecgonine or of their respective salts and all preparations of ecgonine containing less than one-tenth per cent. of ecgonine and all preparations of esters of morphine.
- 3. Dihydrodesoxymorphine (also known as desomorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrodesoxymorphine.
- 4. Pethidine, its salts and any preparation, admixture, extract or other substance containing any proportion of pethidine.
- 5. Any preparation, not being a preparation capable of external use only, made from extract or tincture of Indian Hemp.
- 6. Methyldihydromorphinone (also known as metopon), its salts and any preparation, admixture, extract or other substance containing any proportion of methyldihydromorphinone.
- 7. Alphaprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of alphaprodine.
- 8. Methadone (also known as amidone), its salts and any preparation, admixture, extract or other substance containing any proportion of methadone.
- 9. Betaprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of betaprodine.
- 10. Hydroxypethidine (also known as bemidone), its salts and any preparation, admixture, extract or other substance containing any proportion of hydroxypethidine.

- 11. Isomethadone (also known as isoamidone), its salts and any preparation, admixture, extract or other substance containing any proportion of isomethadone.
- 12. Ketobemidone, its salts and any preparation, admixture, extract or other substance containing any proportion of ketobemidone.
- 13. Methadol, its salts and any preparation, admixture, extract or other substance containing any proportion of methadol.
- 14. Methadyl acetate, its salts and any preparation, admixture, extract or other substance containing any proportion of methadyl acetate.
- 15. Phenadoxone, its salts and any preparation, admixture, extract or other substance containing any proportion of phenadoxone.
- 16. Alphameprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of alphameprodine.
- 17. Betameprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of betameprodine.
- 18. Dihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrocodeine.
- 19. Acetyldihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of acetyldihydrocodeine.
- 20. Methorphinan other than dextrorphan (that is to say, laevorphan dipthonge and racemorphan), its salts and any preparation, admixture, extract or other substance containing any proportion of methorphinan other than dextrorphan.
- 21. 3-Methoxy-N-methylmorphinan other than dextromethorphan (that is to say, laevomethorphan and racemethorphan), its salts and any preparation, admixture, extract or other substance containing any proportion of 3-Methoxy-N-methylmorphinan other than dextromethorphan.
- 22. Methyldesomorphine (6-methyl- \triangle^6 -desoxymorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of methyldesomorphine or its salts.
- 23. 3-Dimethylamino-I: I-di(2-thienyl)-I-butene, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-dimethylamino-I: I-di(2-thienyl)-I-butene.
- 24. 3-Ethylmethylamino-I: I-di(2'-thienyl)-I-butene, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-ethylmethylamino-I: I-di (2'-thienyl)-I-butene.
- 25. 6-Piperidino-4: 4-diphenylheptan-3-one, its salts and any preparation, admixture, extract or other substance containing any proportion of 6-piperidino-4: 4-diphenylheptan-3-one.
- 26. Diethylthiambutene (3-diethylamino-I: I-di (2-thienyl)-I-butene), its salts and any preparation, admixture, extract or other substance containing any proportion of diethylthiambutene.
- 27. 1 Methyl 4 phenylpiperidine 4 carboxylic acid isopropyl ester.
- 28. Normethadone (4: 4-diphenyl-6-dimethylamine-3-hexanone), its salts and any preparation,

admixture, extract or other substance containing any proportion of normethadone.

THE DANGEROUS DRUGS LAW. CAP. 73 and Law 39 of 1953.

ORDER IN COUNCIL No. 2789 made under Section 13 (I).

Whereas by sub-section (I) of section 13 of the Dangerous Drugs Law it is provided that it shall not be lawful for any person in Cyprus to trade in or manufacture for the purpose of trade any of the products obtained from any of the phenanthrene alkaloids of opium or from the ecgonine alkaloids of the coca leaf, not being a product which was on the thirteenth day of July nineteen hundred and thirty-one, being used for medical or scientific purposes, and that the Governor may, if satisfied that any such product is of medical or scientific value, by Order in Council direct that the said sub-section shall cease to apply to that product:

And whereas the Governor is satisfied that the drugs specified in the Schedule to this Order, being products obtained from morphine, one of the phenanthrene alkaloids of opium, which were not on the said date being used for medical or scientific purposes, are of medical value:

Now, therefore, in exercise of the powers vested in him by sub-section (I) of section 13 of the

Dangerous Drugs Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:-

- 1. This Order may be cited as the Dangerous Drugs (Relaxation of Law) Order, 1955.
- 2. Sub-Section (I) of section 13 of the Dangerous Drugs Law shall cease to apply to the drugs specified in the Schedule to this Order.

Schedule.

- 1. Methyldihydromorphinone (commonly known as metopon).
- 2. N-Allylnormorphine.
- 3. Morpholinylethylmorphine.
- 4. Methyldesomorphine $(6-\text{methyl}-\triangle^6-\text{desoxy-morphine})$.
- 5. Diacetyl-N-allylmorphine.
