In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate hereafter the texts of regulations.

Order amending list of narcotic substances

THE MINISTER OF HEALTH,

In view of Article 32 of Act No. 21 of 1928 governing traffic in and the use of narcotic substances:

In view of the recommendation of the general meeting of the Advisory Section and the Legislative Section of the Council of State;

ORDERS:

Article 1. - The following substances are added to the list of narcotic substances referred to in Article 1 of the aforementioned Act:

4: 4 diphenyl - 6 - Morpholinoheptane - 3 - one hydrochloride (known as HEPTALGIN, C B II, or by other names)

Article 2. - This Order shall come into force two months after publication in the "Official Journal."

CIRCULAR No. I of 1950

The Ministry of Public Health informs all pharmacists, owners and managers of private pharmacies and druggist's stores that it has issued an order, dated 4 January 1950, and published in "Official Journal" No. 15 of 26 January 1950, adding the following substance to the narcotic substances listed in Article I of Law No. 21 of 1928 governing the traffic in and use of narcotic substances:

4: 4 diphenyl - 6 - morpholinoheptane - 3 - one hydrochloride (known as Heptalgine, C.B.II or by other names.)

The Ministry has set at 0.25 gr. the amount of the above substances which may be dispensed against one prescription, the total amount which may be dispensed during one month to the same patient not to exceed ten times the above amount.

Where prescriptions ordering the above-mentioned narcotic substance have been filled more than once for the same patient in the course of one week, the Ministry (Pharmaceutical Section) must be advised thereof by registered letter.
