NOTE BY THE SECRETARY-GENERAL

In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

prohibiting the import, manufacture and distribution of narcotic drugs on the Territory of Togoland

Considering the decree of 23 March 1921 determining the duties and powers of the Commissioner of the Republic in Togoland;

Considering the decree of 3 January 1946 on the administrative re-organization of the Territory of Togoland and the creation of representative assemblies;

Considering the decree of 16 April 1924 on the promulgation and publication of rules and regulations in Togoland;

Considering the decree of 4 May 1928 regulating the traffic, possession and use of poisonous substances in Togoland, promulgated in Togoland on 13 November 1928;

Considering the decree No. 47-2425 of 31 December 1947, promulgated in Togoland on 12 January 1948, amending the decree on 4 May 1928;

Considering the Ministerial Decision No. 8,883 of 5 October 1948 on the control of narcotic drugs:

HEREBY ORDERS

Article 1: The import, manufacture and distribution of the following products are prohibited on the Territory of Togoland:

1. DEMETHYLACETYLDIHYDROTHEBAINE and its salts (Acedicone)

2. HYDROXY a-b. DIPHENYLETHYLAMINE and its salts

3. DIMETHYLAMINO-DIPHENYL-HEPTANONE and its salts (Metadon)

Article 2: Infringements of the present order will be punishable by the penalties provided for in articles 43 to 48 inclusive of the aforementioned decree of 4 May 1928.

Article 3: The present order will be registered, communicated and published wherever necessary.
