THE DANGEROUS DRUGS ORDINANCE (CAP. 60)

THE DANGEROUS DRUGS (AMENDMENT) REGULATIONS, 1954\*

In exercise of the powers conferred upon the Minister responsible for Health by section 30 of the Dangerous Drugs Ordinance, the following Regulations are hereby made:-

1. These Regulations may be cited as the Dangerous Drugs (Amendment) Regulations, 1954, and shall be read as one with the Dangerous Drugs Regulations, hereinafter referred to as the principal Regulations.

2. Regulation 36 of the principal Regulations shall be amended by the omission of the words appearing in the sentence immediately after the words "approved by the Governor".

3. In Part (a) of Schedule 2 to the principal Regulations there shall be inserted, immediately below the item headed "35. Yatren," the following words and figures-

"36. Ethnine. Pholcodine, (that is to say, Morpholinylethylmorphine) 4 milligrammes in 4 millilitres."

THE DANGEROUS DRUGS ORDINANCE, (CAP. 60)

THE DANGEROUS DRUGS (EXTENSION OF APPLICATION) ORDER, 1954\*

Whereas it appears to the Minister responsible for Health that the drugs specified in the Schedule to this Order are productive, if improperly used, or are capable of being converted into a substance which is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

Now therefore in exercise of the powers conferred upon the Minister by subsection (3) of section 8 of the Dangerous Drugs Ordinance, it is hereby ordered as follows:-

THE DANGEROUS DRUGS ORDINANCE (CAP. 60)

THE DANGEROUS DRUGS (RELAXATION)
ORDER, 1954\*

Whereas the Minister responsible for Health is satisfied that the drug Morpholinylethylmorphine, being a product obtained from morphine, one of the phenanthrene alkaloids of opium, is of medical value:

Now therefore in exercise of the powers conferred upon the Minister by subsection (1) of section 11 of the Dangerous Drugs Ordinance, it is hereby ordered as follows:—

- 1. This Order may be cited as the Dangerous Drugs (Restriction of Application) Order, 1954.
- 2. Subsection (1) of section 11 of the Dangerous Drugs Ordinance shall cease to apply to the drug Morpholinylethylmorphine.

THE PHARMACY AND POISONS ORDINANCE, 1946 (No. 21 of 1946)

THE PHARMACY AND POISONS (EXTENSION OF SCHEDULE) ORDER, 1954\*

Whereas the Pharmacy and Poisons Board has recommended to the Minister responsible for Health that Schedules II and XIII to the Pharmacy and Poisons Ordinance, 1946, should be amended as provided in this Order.

Now therefore in exercise of the powers conferred upon the Minister by section 79 of the Pharmacy and Poisons Ordinance, 1946, hereinafter called the Ordinance, it is hereby ordered as follows:—

1. This Order may be cited as the Pharmacy and Poisons (Extension of Schedule) Order, 1954.

2. Part I of Schedule II to the Ordinance shall be amended by the addition at the end thereof, of the words contained in the Schedule to this Order.

3. Schedule XIII of the Ordinance shall be amended by the addition at the end thereof, of the words contained in the Schedule to this Order.
