THE DANGEROUS DRUGS ORDINANCE* (Chapter 134)

THE DANGEROUS DRUGS ORDINANCE*

DANGEROUS DRUGS (AMENDMENT OF SCHEDULE) ORDER, 1953.

In exercise of the powers conferred by section 3 of the Dangerous Drugs Ordinance, the Governor in Council has made the following order -

Citation.

1. This order may be cited as the Dangerous Drugs (Amendment of Schedule) Order, 1953.

2. The drugs specified below shall be

included as item No. 28 in the First

Amendment of the First Schedule to the Ordinance to include further

Schedule to the Ordinance.

Dextromethorphan (3-methoxy-Ndrugs (Cap. 134). methylmorphinan) also known as levomethorphan and racemethorphan, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-methoxy-N-methylmorphinan.

DANGEROUS DRUGS CONTROL ORDER, 1953.

In exercise of the powers conferred by subsection (2) of section 20 of the Dangerous Drugs Ordinance, the Governor in Council has made the following Order-

Citation.

1. This Order may be cited as the Dangerous Drugs Control Order, 1953.

Control. (Cap. 134.)

2. The provisions of the Dangerous Drugs Ordinance so far as they relate to the manufacture, import, export and wholesale trade in dangerous drugs shall apply to Morpholinylethylmorphine and its salts: Provided that nothing herein shall be deemed to control the retail trade of any preparation, admixture, extract or other substance containing any proportion of Morpholinylethylmorphine or its salts.

THE PHARMACY AND POISONS ORDINANCE* (Chapter 138).

POISONS (AMENDMENT)(NO.2) REGULATIONS, 1953

In exercise of the powers conferred by section 4 of the Pharmacy and Poisons Ordinance, the Pharmacy Board with the approval of the Governor in Council has made the following regulations—

Citation.

1. These regulations may be cited as the Poisons (Amendment) (No. 2) Regulations, 1953.

Amendment of First List. (Vol. X, p. 68). 2. The First List to the Poisons Regulations (hereinafter referred to as the principal regulations) is amended by the addition at the end thereof of the following—

"Beta-aminopropylbenzene; its salts; its N-alkyl derivatives; their salts; beta-aminoisopropylbenzene; its salts; its N-alkyl derivatives; their salts.

iso-Nicotinic acid hydrazide; its salts; its derivatives; their salts."

Amendment of Second List.

3. The Second List to the principal regulations is amended by the addition at the end of Group II thereof of the following—

Appliances for inhalation in which the poison is absorbed in inert solid material."

"Beta-aminopropylbenzene; its salts; its N-alkyl derivatives; their salts; beta-aminoisopropylbenzene; its salts; its N-alkyl derivatives; their salts.

Amendment of Third List.

4. The Third List to the principal regulations is amended by the addition at the end thereof of the following—

"Beta-aminopropylbenzene; its salts; its N-alkyl derivatives; their salts; beta-aminoisopropylbenzene; its salts; its N-alkyl derivatives; their salts.

iso-Nicotinic acid hydrazide; its salts; its derivatives; their salts."

Amendment of Part I. (Vol. X, p. 100). 2. Part I of the Poisons List is amended by the addition at the end thereof of the following—

"Beta-aminopropylbenzene; its salts; its N-alkyl derivatives; their salts; beta-aminoisopropylbenzene; its salts; its N-alkyl derivatives; their salts.

iso-Nicotinic acid hydrazide; its salts; its derivatives; their salts."
