LAWS AND REGULATIONS

PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL.- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

DECREE No. 4/1960 (III.23)

of the Minister of Health

on the amendment of the list of narcotic drugs

In conjunction with the Minister of the Interior, the Minister for Home Defence, the Minister of Heavy Industry, the Minister of Agriculture, the Minister of Transport and Postal Services and the National Council of Trade Unions, I proclaim the following decree:

Article 1

- 1. In Part 1 of the list of narcotic drugs constituting the annex to Decree No. 5/1957 (XII.14) Ei.M.1/ on the publication of the new list of narcotic drugs liable to produce addiction, the prescription of narcotic drugs for therapeutic purposes, and the regulation for registration of narcotic drugs sold by pharmacies and used for therapeutic purposes in hospitals,
- (a) the words "Dihydrooxicodeinonum / Oxycodone / (Hydrolaudin, Eukodal) and its salts" should be replaced by the words "Dihydrooxicodeinonum (Hydrolaudin, Eukodal, Oxycodone) and its salts";
- (b) the words "Dihydrocodeinonum Enolaceticum (Acedicon) Thebacon and its salts" should be replaced by the words "Dihydrocodeinonum Enolaceticum (Acetyldihydrocodeinone, Acedicone, Diacodon) Thebacon and its salts".
- 2. The following patent medicines should be added to Part 2 of the list of narcotic drugs:
 - 3.079 Diacodon tbl.
 - 3.080 Oxycodone tbl.

Article 2

This decree shall come into force on the day of its promulgation.
