PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

No. 1639-E&T-55/1839-A. In exercise of the powers conferred by sections 17(a) and 24(4) of the Punjab Excise Act, (I of 1914), the Governor of Punjab is pleased hereby to make the following orders prohibiting the import and possession of charas as an intoxicant:—

These orders may be called the Punjab Import and Possession of Charas Orders, 1955, and shall come into force at once.

THE PUNJAB IMPORT AND POSSESSION OF CHARAS ORDERS, 1955

The import into the State of Punjab and the possession of any quantity of charas, or any preparation or admixture thereof or of any substance obtained from the Indian hemp plant and used as a substitute for charas by any person within Punjab is prohibited.
