NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

APPENDIX.

NOTIFICATION.

In exercise of the powers conferred by subsection (2) of section 8 of the Dangerous Drugs Act, 1930 (Central Act II of 1930), the Governor of Madras hereby makes the following amendments to the Madras Manufactured Drugs Rules, 1932 (published with Revenue Department Notification No. 203, dated the 29 April 1932, at pages 798-806 of

Part I of the Fort St. George Gazette, dated the 3 May 1932, as subsequently amended).

AMENDMENTS.

In the said rules:-

- (1) in rule 2, the word "and" at the end of clause(i) shall be omitted;
- (2) in rule 25, after the word "inspection" the words "by any Officer of the Excise Department not below the rank of Assistant Inspector or" shall be inserted;
 - (3) in Form MI
- (a) for condition IV, the following condition shall be substituted, namely:-
- "IV. No consignment of manufactured drugs other than prepared opium imported shall be opened before it has been verified and passed by an Officer of the Excise Department not below the rank of Sub Inspector";
 - (b) in condition XIII -
- (i) after the words "approved practitioner" in clause (a), the words "by any officer of the Excise Department not below the rank of Assistant Inspector or" shall be inserted;
- (ii) after the words "by an officer of" in clause (b), the words "the Excise or" shall be inserted.
- (c) for condition XIV, the following condition shall be substituted, namely:-
- "XIV. An Inspection note book with pages numbered consecutively shall be maintained for the use of inspecting officers and shall be handed over to the Assistant Inspector of Excise, the Assistant Prohibition Officer or the Inspector of Police, as the case may be, or to any officer authorised by any of them to receive it on a receipt being given therefor. The book shall be preserved in good condition and handed over to the Excise Sub Inspector at the end of the period for which the licence is in force";
 - (4) in Form M2 -
- (a) for condition IV, the following condition shall be substituted, namely:-
 - "IV. No consignment of manufactured drugs

other than prepared opium imported shall be opened before it has been verified and passed by an Officer of the Excise department not below the rank of Sub Inspector";

- (b) in condition XII, for the words "to the Prohibition Officers or to the Police Officers, as the case may be" in the second sentence, the words "to the Excise Officers" shall be substituted;
 - (c) in condition XIV -
- (i) after the words "approved practitioner" in clause (a), the words "by any officer of the Excise Department not below the rank of Assistant Inspector or" shall be inserted;
- (ii) after the words "by any Officer of" in clause (b), the words "the Excise or" shall be inserted:

- (d) for condition XV, the following condition shall be substituted, namely:-
- "XV. An inspection note book with pages numbered consecutively shall be maintained for the use of inspecting officers and shall be handed over to the Assistant Inspector of Excise, the Assistant Prohibition Officer or the Inspector of Police, as the case may be, or to any officer authorised by any of them to receive it on a receipt being given therefor. The book shall be preserved in good condition and handed over to the Excise Sub-Inspector at the end of the period for which the licence is in force."
