LAWS AND REGULATIONS

PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF
THE INTERNATIONAL TREATIES ON NARCOTIC DRUGS

INDIA

Communicated by the Government of India

NOTE BY THE SECRETARY-GENERAL - In accordance with the relevant Articles of the International Treaties on Narcotic Drugs, the Secretary-General has the honour to communicate the following legislative texts.

NOTE

- (i) The Government of Gujarat, Education and Labour Department Notification No. GH/SH/3012/BPA-1271/32046/P, dated 10 June, 1971

Under this Notification, the Government of Gujarat has promulgated the Gujarat Poppy Capsules (Amendment) Rules, 1971, thereby amended Rule 13(2) and Licence Form Poppy-2 of the Gujarat Poppy Capsules Rules, 1963, so as to dispense with the necessity of obtaining the signature of the purchaser on the licensee register in consequence of the limit of possession of poppy capsules without a licence, permit or pass, having been lowered from 500 grams to 100 grams.

- (ii) The Government of Gujarat, Education and Labour Department Notification No. GH-SH-2433/DDA-1268/75972-P, dated 9 January, 1971

Under this Notification, the Government of Gujarat substituted the Schedule attached to the Bombay Dangerous Drugs Rules, 1935, as applicable to the State of Gujarat, thereby bringing under control all the drugs included in Schedule II of the Single Convention on Narcotic Drugs, 1961.

GUJARAT POPPY CAPSULES (AMENDMENT) RULES, 1971

EDUCATION AND LABOUR DEPARTMENT

Bombay Prohibition Act, 1949

Whereas the Government of Gujarat considers that the rules hereinafter appearing should be brought into force at once by dispensing with the previous publication;

Now, therefore, in exercise of the powers conferred by sub-section (1) read with clause (hl) of sub-section (2) of section 143 of the Bombay Prohibition Act, 1949 1/ (Bom. XXV of 1949), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Poppy Capsules Rules, 1963, 2/* namely:

1. These rules may be called the Gujarat Poppy Capsules (Amendment) Rules, 1971.

2. In sub-rule (2) of rule 13 of the Gujarat Poppy Capsules Rules, 1963 (hereinafter referred to as "the said rules") the portion beginning with the words "He shall, in the cases where no permit or pass is required" and ending with the words "obtain in the said register the signature of the purchaser" shall be deleted.

3. In FORM POPPY-2 appended to the said rules in paragraph (2) of condition 4, the portion beginning with the words "He shall in cases where no permit or pass is required" and ending with the words "obtain in the said register the signature of the purchaser" shall be deleted.

DANGEROUS DRUGS ACT, 1930.

In exercise of the powers conferred by rule 40 of the Bombay Dangerous Drugs Rules, 1935, the Government of Gujarat, hereby amends the former Government of Bombay Revenue Department Notification No. DDR-1056/59343 (a) -J, dated 21 May, 1959 3/ (hereinafter referred to as "the said notification") as follows:

In the said notification, for the existing schedule the following new Schedule shall be substituted:

SCHEDULE

1. Methyl morphine (commonly known as "Codeine") and Ethyl morphine and their Salts (including Dionine) all dilutions and preparations except those which are compounded with one or more other ingredients and containing not more than 100 milligrammes of the drugs per dosage unit and with a concentration of not more than 2.5 per cent in undivided preparations and which have been established in therapeutic practice.
2. Dihydrocodeine 4/ and Acetyldihydrocodeine, other derivatives of Dihydrocodeine and their salts (such as PARACODINE and ACETYL CODONE and the like) all dilutions and preparations, except those which are compounded with one or more other ingredients and containing not more than 100 milligrammes of the drug per dosage unit and with a concentration of not more than 2.5 per cent in undivided preparations and which have been established in therapeutic practice.
3. Beta-4- Morpholinylethyl morphine (also known as HOMOCODEINE, HYBERNIL, PHOLGODINE and the like) and its salts, all dilutions and preparations, except those which are compounded with one or more other ingredients and containing not more than 100 milligrammes of the drug per dosage unit and with a concentration of not more than 2.5 per cent in undivided preparations and which have been established in therapeutic practice.
4. Norcodeine and its salts all dilutions and preparations except those which are compounded with one or more other ingredients and containing not more than 100 milligrammes of the drug per dosage unit and with a concentration of not more than 2.5 per cent in undivided preparations and which have been established in therapeutic practice.
5. 6-nicotinylcodeine (the proposed international non-proprietary name of which is nicocodine) and its salts, all dilutions and preparations, except those which are compounded with one or more other ingredients and containing not more than 100 milligrammes of the drug per dosage unit and with a concentration of not more than 2.5 per cent in undivided preparations and which have been established in therapeutic practice.
