PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

Extract from the Register of Decrees of The Acting Chief of the Public Health Service. Batavia, 8 January 1948

THE ACTING CHIEF OF THE PUBLIC HEALTH SERVICE.

Having considered: the letter of the League of Nations dated Geneva, 10 May 1946, No. C. L. 11.1946.XI.; Having further considered: Decree No.27991/F of 26 September 1930;

Considering: that the substance known as 1-methyl-4-phenylpiperidine-4-carboxylic acid ethyl ester, known in the trade under such names as: Dolantin, Demerol, Pethidine, is not a substance within the meaning of art.1, sub.ee, paragraphs 1 to 5 (Staatsblad 1927 Nos. 278 and 536) of the Narcotic Drugs Ordinance;

that according to the said letter of the League of Nations art.10 of the Opium Convention of Geneva, 1925, has been declared to be applicable to the aforesaid substance; that accordingly it is necessary that this substance should be expressly designated pursuant to art.1, sub.ee, paragraph 6 of the said Ordinance;

<u>Decides</u>: In consequence of the repeal of Decree No. 27991/F of 26 September 1930 (<u>Bijblad</u> 13776) - which Decree as far as is ascertainable from the post-war data of the relevant archives, must be presumed to be the latest enactment pertaining to this matter - to establish the following list of narcotic drugs referred to in article 1, sub.ee, paragraph 6 of the Narcotic Drugs Ordinance (<u>Staatsblad</u> 1927, Nos. 278 and 536) Ethylnarceine (Narcyl)

THE MINISTER OF HEALTH OF THE REPUBLIC OF INDONESIA

Having considered the letters of the:

- 1. Secretary-General of the United Nations, New York, dated 5 March 1951, No. SOA 110/01 C.N. No. 20, and of the
- 2. Inspector, Pharmaceutical Division, dated 8 October 1951, No.976/Ph;

Having also considered the letter of the Chief of the Government Salt Monopoly Service, dated 26 August 1949, No.5243:

Considering:

(a) that according to the letters of the Secretary-General of the United Nations dated 5/3/51 No.SOA 110/01 C.N. 20 and 27/4/'49 No.C.N. 52-1949 Narc. the drugs hereinafter enumerated under Nos. 1 to 10 inclusive contain elements which are liable to produce addiction, and that the drug mentioned under No. 11 and another drug, mentioned previously in the "Alphabetic List of Narcotic Drugs" may be listed as drugs liable to produce addiction;

(b) that, therefore, it is necessary to consider these drugs as being included in art. 1 ee sub 6 of the

Narcotic Drugs Ordinance;

Having in mind the decree of the Acting Chief of the Public Health Service dated 8 January 1948 No.357/A.Z. and 25 February 1928 No.4606 (Alphabetic List of Narcotic Drugs);

DECIDES

That the following drugs shall be deemed to be drugs included in art. 1 sub ee paragraph 6 of the Narcotic Drug Ordinance (Staatsblad 1927 No.278) as subsequently revised:

- 1. 4-(3-hydroxyphenil)-1-methyl-4-piperidyl ethyl ketone and its salts, known in the trade as Ketobemidone and Cliradon.
- 2. 1-methyl-4-metahydroxyphenil-piperidine-4-carboxylic acid ethyl ester and its salts, known in the trade as Bemidone.
- 3. $\[< 1, 3 \]$ -dimethyl-4-phenyl-4-propionoxypiperidine and its salts, known in the trade under such names as Alphaprodine and Nisentil.
- \ \ 4. \ \ \ \ \ 4-1,3-dimethyl-4-phenyl-4-propionoxypiperidine and its salts, known in the trade as Betaprodine.
 - 5. 6-dimethylamino-4,4-diphenyl-3-heptanone and its

salts, known in the trade under such names as Methadone, Adanon, Amidone, Butalgin, Depridol, Diaminon, Dianone, Dolafin, Dolamid, Dolophine, Dorexol, Heptanal, Hoechst 10820, Ketalgin, Mecodin, Mephenon, Miadone, Physeptone, Physopeptone, Polamidon, Symoron, Turanone.

6. 6-dimethylamino-5-methyl-4,4-diphenyl-3-hexanone and its salts, known in the trade as Isomethadone.

7. 6-dimethylamino-4,4-diphenyl-3-heptanol and its salts, known in the trade as Methadol.

/ 8. 4,4-diphenyl-6-dimethylamino-3-acetoxyheptane and its salts.

9. 6-morpholino-4,4-diphenyl-3-heptanone and its salts, known in the trade under such names as Phenadoxone, Hepagin, Heptalgin, Heptalin and Heptazone.

10. Methyldihydromorphinone and its salts, known in the trade as Metopon.

11. Acetyldihydrocodeinone and its salts.
