LAWS AND REGULATIONS

The Dangerous Drugs Ordinance (Cap.129)

In exercise of the powers conferred by sub-section (3) of section 14 of the Dangerous Drugs Ordinance, the Minister for Local Government, Health and Town Planning, hereby makes the following Order:

THE DANGEROUS DRUGS (APPLICATION) ORDER, 1958

1. This Order may be cited as the Dangerous Drugs (Application) Order, 1958.
2. The provisions of Part V of the Ordinance shall apply to the drugs specified in the Schedule hereto in the same manner as they apply to the drugs mentioned in sub-section (1) of section 14 of the Ordinance.

SCHEDULE

1. Alphameprodine, ^{1/} its salts and any preparation, admixture, extract or other substance containing any proportion of alphameprodine.
2. Alphaprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of alphaprodine.
3. Betameprodine, its salts and any preparation, admixture, extract or other substance containing any proportion of betameprodine.

4. Diethylthiambutene, its salts and any preparation, admixture, extract or other substance containing any proportion of diethylthiambutene.
5. 1:3-Dimethyl-4-phenyl-4-propionyloxyhexamethyleneimine /1,3-dimethyl-4-phenyl-4-propionyloxyhexamethyleneimine or proheptazine /its salts and any preparation, admixture, extract or other substance containing any proportion of 1:3-dimethyl-4-phenyl-4-propionyloxyhexamethyleneimine.
6. Dimethylthiambutene, its salts and any preparation, admixture, extract or other substance containing any proportion of dimethylthiambutene.
7. Dioxaphetyl butyrate (4-morpholino-2:2-diphenyl ethyl butyrate) /ethyl-4-morpholino-2,2-diphenylbutyrate / its salts and any preparation, admixture, extract or other substance containing any proportion of dioxaphetyl butyrate (4-morpholino-2:2-diphenyl ethyl butyrate).
8. Dipipanone, its salts and any preparation, admixture, extract or other substance containing any proportion of dipipanone.
9. Ethylmethylthiambutene, its salts and any preparation, admixture, extract or other substance containing any proportion of ethylmethylthiambutene.
10. Levorphanol, its salts and any preparation, admixture, extract or other substance containing any proportion of levorphanol.
11. Methyl-desomorphine /methyl-desorphine / (6-methyl- Δ^6 -desoxymorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of methyl-desomorphine (6-methyl- Δ^6 -desoxymorphine).
12. 1-Methyl-4-phenylpiperidine-4-carboxylic acid isopropyl ester, /properidine / its salts and any preparation, admixture, extract or other substance containing any proportion of 1-methyl-4-phenylpiperidine-4-carboxylic acid isopropyl ester.
13. Normethadone, its salts and any preparation, admixture, extract or other substance containing any proportion of normethadone.
14. Phenomorphan (3-hydroxy-N-phenethylmorphinan), its salts and any preparation, admixture, extract or other substance containing any proportion of phenomorphan (3-hydroxy-N-phenethylmorphinan).
15. Propoxyphene (4-dimethylamino-1:2-diphenyl-3-methyl-2-propionyloxybutane) /4-dimethylamino-3-methyl-1,2-diphenyl-2-propionoxybutane /its salts and any preparation, admixture, extract or other substance containing any proportion of propoxyphene (4-dimethylamino-1:2-diphenyl-3-methyl-2-propionyloxybutane).
16. Racemorphan, its salts and any preparation, admixture, extract or other substance containing any proportion of racemorphan.
