LAWS AND REGULATIONS

PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

MADAGASCAR

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

Order No. 2144-AP/4 promulgating (1) Act No. 54-418 of 15 April 1954 extending to Overseas Territories, Togoland and the Cameroons certain provisions of the Public Health Code relating to the practice of pharmacy; (2) Decree No. 55-1122 of 16 August 1955 determining the procedure for applying the above-mentioned Act No. 54-418 of 15 April 1954; (3) Decree No. 55-1123 of 16 August 1955 determining the rules concerning the replacement of pharmacists during their absence in application of Article 3 of the above-mentioned Act No. 54-418 of 15 April 1954.

The Governor General of France Overseas, High Commissioner of the French Republic of Madagascar and Dependencies makes the following Order, in virtue of:

The Decrees of 11 December 1895 and 30 July 1897

Article 1. -

In the territory of Madagascar and Dependencies, the following are hereby promulgated:

- 1) Act No. 54-418 of 15 April 1954¹⁾ extending to the Overseas Territories, Togoland and the Cameroons certain provisions of the Public Health Code relating to the practice of pharmacy;
- 2) Decree No. 55-1122 of 16 August 1955²⁾ determining the procedure for applying the above-mentioned Act No. 54-418 of 15 April 1954;
- 3) Decree No. 55-1123 of 16 August 1955³⁾ determining the rules concerning the replacement of pharmacists during their absence, in application of Article 3 of the above-mentioned Act No. 54-418 of 15 April 1954.
