PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

MAURITIUS

Communicated by the Government of the United Kingdom of Great Britain and Northern Ireland

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

Proclamation No. 2 of 1953

E/NL.1954/24 (M.P.7045/I)

To Proclaim that Section 32 (I) of the Dangerous Drugs Ordinance, 1950, shall cease to apply to the Drug N-Allylnormorphine.

&с, WHEREAS by subsection (I) of section thirtytwo of the Dangerous Drugs Ordinance, 1950, it is provided that it shall not be lawful for any person to trade in or manufacture for the purpose of trade any products obtained from any of the phenanthrene alkaloids of opium or from the ecgonine alkaloids of the coca leaf, not being a product which was on the thirteenth day of July, nineteen hundred and thirty-one, being used for medical or scientific purposes, and that the Governor may, if satisfied as respects any such product that it is of medical or scientific value, by Proclamation direct that the subsection shall cease to apply to that product:

AND WHEREAS I am satisfied that the drug N-Allylnormorphine, being a product obtained from morphine, one of the phenanthrene alkaloids of opium, which was not on the said date being used for medical or scientific purposes, is of medical

NOW, THEREFORE, in pursuance of the power conferred upon me by subsection (I) of section thirty-two of the Dangerous Drugs Ordinance, 1950, I do hereby proclaim and order as follows -

- I. This Proclamation may be cited as the Dangerous Drugs Ordinance (Relaxation) Proclamation, 1953.
- 2. Subsection (I) of section thirty-two of the Dangerous Drugs Ordinance, 1950, shall cease to apply to the drug N-Allylnormorphine.

Order made by the Governor upon the recommendation of the Director of Medical Services under Section 37 of the Pharmacy Ordinance.

- 2. Part I of Schedule A to the Pharmacy Ordinance is amended by the substance men- Cap. 275. tioned in the Schedule to this Order being inserted in its proper alphabetical place.

SCHEDULE

3-Methoxy-N-methylmorphinan (that is to say, dextromethorphan, levomethorphan and racemethorphan), its salts and any preparation, admixture, extract or other substance containing any proportion of 3-methoxy-N-methylmorphinan.

WHEREAS by Section 10 of the Dangerous Drugs Ordinance, 1950, it is enacted that if the Governor is satisfied, on representation made to him in that behalf, that any new derivative of morphine or cocaine or of any salts of morphine or cocaine or any other alkaloid of opium or any other drug of whatever kind is, or is likely to be, productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be, productive, if improperly used, of ill-effects substantially of the same character or nature as, or analogous to, those produced by the substances mentioned in Section 9 of the said Ordinance, the Governor may by Proclamation declare that Part IV of the said Ordinance shall apply to that new derivative or alkaloid or other drug in the same manner as it applies to the drugs mentioned in the said Section 9:

AND WHEREAS I am satisfied, on representation made to me, that the drugs specified in the Schedule to this Proclamation are, or are likely to be, productive, if improperly used, or are capable of being converted into a substance which is, or is likely to be, productive, if improperly used, of ill-effects substantially of the same character or nature as, or analogous to, those produced by the substances mentioned in the said Section 9:

NOW, THEREFORE, in pursuance of the powers conferred upon me by section 10 of the said Ordinance, I do hereby proclaim and order as follows:-

- I. This Proclamation may be cited as the Dangerous Drugs Ordinance (Application) Proclamation,
- 2. Part IV of the Dangerous Drugs Ordinance, 1950, shall apply to the drugs specified in the Schedule to this Proclamation in the same manner as the said Part IV applies to the Drugs mentioned in section 9 of that Ordinance.
