## NOTE BY THE SECRETARY-GENERAL

In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

## MINISTRY OF SOCIAL AFFAIRS

Notification of narcotic drugs under the Opium Act (Staatsblad 1928, No. 167) 8 June 1951 / Public Health Section I / No. 11267

The Minister of Social Affairs,

In consideration of article 2, under 1, g, of the Opium Act (Staatsblad 1928 No. 167), amended by the Act of 28 July 1933 (Staatsblad 1933, No. 381);

In view of the Ministerial Order of 8 December 1933, No. 1762 P (Nederlandse Staatscourant of 11 December 1933, No. 241), as amended, for the enforcement of the said article of the aforesaid Act; Has deemed it fitting:

To supplement the said Order by adding to the substances listed under figure 2 after 1-methyl-4 phenylpiperidine-4-carbonic acid ethyl-ester and its salts (such as dolantine, dolantal, demerol, pethidine):

1-methyl-4-(3-Hydroxyphenyl)-4-piperidyl-ethylketon and its salts (such as ketobemidon);

1-methyl-4-(3-hydroxyphenyl) piperidine-4-carbonic acid ethyl-ester and its salts (such as bemidon);

A -1, 3-dimethyl-4-phenyl-4-propionoxy-piperidine and its salts (such as nisentil);

B -1, 3-dimethyl-4-phenyl-4-propionoxy-piperidine and its salts;

by adding after 4, 4-diphenyl-6-dimethylaminoheptanon-3 and its salts (such as amidone, methadon, symoron):

- 4, 4-diphenyl-5-methyl-6-dimethylamino-hexanon-3 and its salts (such as isomethadon);
- 4, 4-diphenyl-6-dimethylamino-heptanol-3 and its salts;
- 4, 4-diphenyl-6-dimethylamino-3-acetoxyheptan and its salts.
- 4, 4-diphenyl-6-morpholino-heptanon-3 and its salts (such as heptazon, heptalgine), and

by adding after methyl-dihydromorphinon and its salts (such as metopon): dihydrocodeine and its salts (such as codhydrine) acetyldihydrocodeine and its salts (such as acetylcodon).
