#### DESIGNATION AS NARCOTIC DRUGS

#### DEPARTMENT OF PUBLIC HEALTH, DIVISION OF HEALTH PROTECTION

The Minister of Social Affairs and Public Health,

Having regard to the Order of 24 February 1958, No. 1685<sup>\*/</sup>, Department of Public Health, Division of Health Protection ("Staatscourant" 48)<sup>(1)</sup>;

Considering article 2, paragraph 1, sub-paragraph g, and article 6, paragraph 1, sub-paragraph a, of the Opium Act ("Staatsblad" 1928, 167)<sup>(2)</sup>;

Hereby orders as follows :

#### SOLE ARTICLE

In the Order of 24 February 1958, No. 1685, Department of Public Health, Division of Health Protection, the following narcotic drugs shall be added in article 1, paragraph 3 :

Allylprodine<sup>\*\*</sup> 3-allyl-1-methyl-4-phenyl-4-propionoxypiperidine,  $C_{18}H_{25}ON$  and its salts;

Benzethidine (1-(2-benzyloxyethyl)-4-phenylpiperidine-4-carbonic acid ethyl ester,  $C_{23}H_{29}O_3N$ ) /1-(2-benzyloxyethyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester/\*\*\*\* and its salts;

Purethidine (1-(2-tetrahydrofurfuryloxyethyl)-4-phenylpiperidine-4-carbonic acid ethyl ester,  $C_{21}H_{31}O_4N$ ) /1-(2-tetrahydrofurfuryloxyethyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester/ and its salts;

Levophenacymorphan ((-)-3-hydroxy-N-phenacymorphan,  $C_{24}H_{27}O_2N$ ) and its salts;

Metazocine (1,2,3,4,5,6-hexahydro-8-hydroxy-3,6,11-trimethyl-2,6-methano-3-benzazocine,  $C_{15}H_{21}ON$ ) and its salts;

Norlevorphanol ((-)-3-hydroxymorphan,  $C_{16}H_{21}ON$ ) and its salts;

Phenazocine (1,2,3,4,5,6-hexahydro-8-hydroxy-6,11-dimethyl-3-phenethyl-2,6-methano-3-benzazocine,  $C_{22}H_{27}ON$ ) and its salts;

Piminedine (1-(3-phenylaminopropyl)-4-phenylpiperidine-4-carbonic acid ethyl ester,  $C_{23}H_{30}O_2N_2$ ) /1-(3-phenylaminopropyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester/ and its salts.
