Has decided:

## Article I

Order No. 1,685 of 24 February 1958 of the Public Health Department, Health Protection Divisionii/ shall be amended as follows:

- Last amended by the Order of 26 February 1965 (Government Gazette No. 46 of 1965) (E/NL.1967/11).

The text of para. 2 of Article 1 shall read as follows:

2. Concentrate of poppy straw (i.e. the substance obtained by subjecting poppy straw to a process for concentrating its alkaloids).

The present number 2 shall be renumbered 3.

C

The present number 3 shall be renumbered 4, with the following additions:

Piritramide 2/ (1-(3-cyano-3, 3-diphenylpropyl)-4-(1-piperidine-4-carboic acid amide) and its salts. /1-(3-cyano-3, 3-diphenylpropyl)-4-(1-piperidino) piperidine-4-carboxylic acid amide/2/

<u>Nicodicodine</u> (6-nicotinyldihydrocodeine,  $C_{24}H_{26}O_{4}N_{2}$ ) and its salts.

The present number 4 shall be renumbered 5, and the structural formula of nicocodine shall be changed from  $^{\rm C}_{24}{}^{\rm H}_{26}{}^{\rm O}_{4}{}^{\rm N}_{2}$  into  $^{\rm C}_{24}{}^{\rm H}_{24}{}^{\rm O}_{4}{}^{\rm N}_{2}$ .

The present number 5 shall be renumbered 6, and the words "all the preparations of the ... under 3 and 4" to be amended into "all the preparations of the ... under 4 and 5".

F

The present number 6 shall be renumbered 7, and the following addition made:

Pethidine intermediate -C (1-Methyl-4-phenyl-piperidine-4-carboxylic acid, C<sub>13</sub>H<sub>17</sub>O<sub>2</sub>N) and its salts.

G

The present number 7 shall be renumbered 8.

H

The present number 8 shall be deleted.
