BOARD REGULATION NO. 2 S.1978

SUBJECT: Amendment to Board Regulation No. 18, series of 1973 1/ Governing the Disposition of Seized or Confiscated Dangerous Drugs Having Legitimate Medical and/or Therapeutic Value.

Pursuant to the provisions of Section 36 of Republic Act No. 6425, as amended, and to fully implement Section VI of Board Regulation No. 4, series of 1972 2/ of the Dangerous Drugs Board, Board Regulation No. 18, series of 1973 is hereby amended insofar as Section 1 thereof is concerned, which shall henceforth read as follows:

Section 1. A committee composed of the Chief of the Custody and Disposal Unit of the Dangerous Drugs Board, as Chairman, one physician from the Dangerous Drugs Board, one chemist from the National Bureau of Investigation (NBI), one chemist from the Philippine Constabulary (PC Crime Laboratory), and one pharmacist from the Food and Drug Administration (FDA), as members, all to be designated by the heads of the agencies concerned, is hereby created to examine and classify seized or confiscated dangerous drugs which are in the custody of the NBI as Dangerous Drugs Custodian duly appointed by the Board, or of the Philippine Constabulary.

All other provisions of the said regulation shall continue to remain in force and effect.

This Regulation shall take effect immediately.

BOARD REGULATION NO. 3 S.1978

SUBJECT: Inclusion of all Pharmaceutical Preparations with Propoxyphene HCl as active ingredient in the list of Regulated Drugs.

In view of the reported abuse of pharmaceutical products with Propoxyphene HCl as active ingredient and the adverse effects of such abuse, the Dangerous Drugs Board, pursuant to the powers vested in it under Section 36(a) of R. A. 6425 3/, as amended, and consistent with its decision arrived at in a meeting of April 12, 1978, hereby includes all such preparations in the list of regulated drugs.

This Regulation supplements Board Regulation No. 6, series of 1972 4/ and shall take effect immediately.
