In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

An Ordinance to amend the Dangerous Drugs Ordinance, 1935,
Ordinance No. 26 of 1935.

Enacting

ENACTED by the Governor of Colony of Seychelles with the advice and consent of the Legislative Council thereof.

Short title.

1. This ordinance may be cited as the Dangerous Drugs (Amendment) Ordinance, No. 35 of 1948, and shall be read and construed as one with the Dangerous Drugs Ordinance, No. 26 of 1935, hereinafter referred to as the principal ordinance.

Paragraph (f)
of section 15
amended.

2. Paragraph (f) of section 15 of the principal ordinance is amended by deleting the semi-colon at the end thereof and by adding the following: -

"or of the other esters of morphine and any preparation, admixture, extract or other substance containing any proportion of ecgonine".

Paragraph (h)
of section 15
amended.

3. Paragraph (h) of section 15 of the principal ordinance is amended by deleting the brackets and words "with the exception of methyilmorphine, commonly known as codeine, and ethylmorphine, commonly known as dionin, and their respective salts)".

Paragraph (i)
of section 15
amended.

4. Paragraph (i) of section 15 of the principal ordinance is amended by deleting the full stop at the end thereof and by adding the following words: -

"except in the case of preparation of methyilmorphine or ethylmorphine, syrupus codeinæphosphatus B.P.C. 1934 and preparations, admixtures or other substance containing not more than 2.5% of methyilmorphine or ethylmorphine (calculated as pure drug) associated with other medicinal substances".

5. The following new paragraphs are added immediately after paragraph (i) of section 15 of the principal ordinance: -

Paragraphs
j, k, l, m
and n added
to section 15.

- " (j) Dihydrodesoxymorphine (commonly known as desomorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrodesoxymorphine".
- " (k) Pethidine (1 methyl-4-phenyl-piperidine-4 carboxylic acid ethyl ester), its salts and any preparation, admixture, extract or other substance containing any proportion of pethidine".
- " (l) Any preparation, not being a preparation capable of external use only, made from extract or tincture of Indian Hemp".
- " (m) Amidone (dl-2-dimethylamino-4; 4-diphenyl-heptane-5-One), its salts and any preparation, admixture, extract or other substance containing any proportion of amidone".
- " (n) Methyldihydromorphinone (commonly known as Metopon), its salts and any preparation, admixture, extract or other substance containing any proportion of methyldihydromorphinone".
