The Dangerous Drugs Ordinance (Chapter 137)

THE DANGEROUS DRUGS (AMENDMENT) REGULATIONS, 1965

In exercise of the powers conferred by section 16 of the Dangerous Drugs Ordinancel/, the Minister for Health hereby makes the following Regulations:

1. These Regulations may be cited as the Dangerous Drugs (Amendment) Regulations, 1965.

G.N. Nos. 2. The Dangerous Drugs Regulations, 19512/, are hereby amended by deleting S 82/51 paragraph (f) of Part I of the Third Schedule thereto and substituting therefor the following:

- "(f) <u>Diphenoxylate</u>2/ and its salts contained in
 - (i) pharmaceutical preparations in solid or liquid form containing not more than 2.5 milligrammes of <u>diphenoxylate</u> calculated as base and not less than 25 microgrammes of atropine calculated as atropine sulphate per dosage unit and containing no other substance to which any part of the Ordinance applies; or
 - (ii) liquid preparations containing 0.5 milligrammes <u>diphenoxylate</u> hydrochloride, 0.005 milligrammes atropine sulphate, 0.16 millilitres ethyl alcohol, 0.002 millilitres imitation cherry flavour, 0.45 millilitres glycerine, 0.4 millilitres sorbital solution (70 per cent), 0.01 milligrammes red dye colour index No. 14700 (F.D. 4C. Red No. 4), 0.0008 millilitres water.".
