PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

THE DANGEROUS DRUGS ORDINANCE

(Cap. 101)

In exercise of the powers conferred upon the Governor by sub-section (2) of section 4 of the Dangerous Drugs Ordinance, I, John Reynolds Stebbing, Officer of the Most Excellent Order of the British Empire, Acting Governor and Commander-in-Chief in and over the Somaliland Protectorate, do hereby declare that Part III of the said Ordinance shall apply to the drugs specified in the Schedule hereto in the same manner as it applies to the drugs mentioned in sub-section (1) of section 4 of the said Ordinance.

2. The Schedule to the Proclamation set forth at page 714 of Volume III of the Somaliland Laws is accordingly amended by adding at the end thereof the said drugs.

- (8) 3-Dimethylamino-1 : 1-di-(2-thienyl)-1-butene, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-dimethylamino-1 : 1-di-(2-thienyl)-1-butene.
- (9) 3-Ethylmethylamino-1 : 1-di-(2-thienyl)-1-butene, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-ethylmethylamino-1 : 1-di-(2-thienyl)-1-butene.
- (10) 6-Piperidino-4 : 4-diphenylheptan-3-one, its salts and any preparation, admixture, extract or other substance containing any proportion of 6-piperidino-4 : 4-diphenylheptan-3-one.
- (11) Diethylthiambutene (3-diethylamino-1 : 1-di-(2-thienyl)-1-butene), its salts and any preparation, admixture, extract or other substance containing any proportion of diethylthiambutene.
- (12) 1-Methyl-4-phenylpiperidine-4-carboxylic acid isopropyl ester, its salts and any preparation, admixture, extract or other substance containing any proportion of 1-methyl-4-phenylpiperidine-4-carboxylic acid isopropyl ester.
- (13) Normethadone (4 : 4-diphenyl-6-dimethylamino-3-hexanone), its salts and any preparation, admixture, extract or other substance containing any proportion of normethadone.
