In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

STATUTORY RULES AND ORDERS, 1951, No. 54.

8th December, 1951.

WHEREAS by subsection (2) of section 13 of the Dangerous Drugs Ordinance, 1938, (No. 20 of 1938) power is conferred on the Governor in Council to declare that Part V of the said Dangerous Drugs Ordinance, 1938, shall apply to any drug of whatever kind in the same manner as it applies to the drugs mentioned in subsection (1) of the said section 13 if it appears to the Governor in Council that the drug is or is likely to be productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be productive if improperly used, of ill-effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

AND WHEREAS it appears to the Governor in Council that the drugs specified in the Schedule to this Order are productive, if improperly used, or are capable of being converted into a substance which is or is likely to be productive, if improperly used, of ill-effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

NOW, THEREFORE, the Governor in Council in pursuance of the power conferred upon him by subsection (2) of section 13 of the Dangerous Drugs Ordinance, 1938, (No. 20 of 1938) is pleased to order and declare, and it is hereby ordered and declared as follows:--

- 1. Short Title. This Order may be cited as the Dangerous Drugs (No. 2) Order, 1951.
- 2. Application of Part V of the Ordinance. Part V of the Dangerous Drugs Ordinance, 1938 (No. 20 of 1938) shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part V applies to the drugs mentioned in subsection (1) of section 13 of the said Dangerous Drugs Ordinance, 1938.

SCHEDULE.

Dihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of dihydrocodeine.

Dangerous Drugs (No. 2) Order

Acetyldihydrocodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of acetyldihydrocodeine.

4--Propionozy--4--phenyl--l--methyl--3--ethylpiperidine, its salts and any preparation, admixture, extract or other substance containing any proportion of 4--propionoxy--4--phenyl--l--methyl--3--ethylpiperidine.

3--Hydroxy-N-methylmorphinan, its salts and any preparation, admixture, extract or other substance containing any proportion of 3--hydroxy--N--methylmorphinan.
