ROYAL ORDER

No. 91

amending the Order of 16 September 1933
(No. 559) containing provisions on narcotic
substances and preparations

Stockholm Palace, 14 October 1960

(SFS 1960: 561)

His Majesty the King has been pleased to order that article 11 of the Order of 16 September 1933 containing provisions on narcotic substances and preparations shall cease to have effect, and that articles 1, 3, 12, 13 and 14^{1/} of the said Order shall be amended to read as follows:

Article 1

This Order applies to:

A.1 Raw opium, by which is meant in the trade;

- 10.f. alpha-phenyl-beta-aminopropane and its N-alkyl derivatives,
2-phenyl-3-methylmorpholine,
1,1-diphenyl-1-piperidyl-(2)-methanol (pipradrol) and
2-phenyl-2-piperidyl-(2)-acetic acid methyl ester (methylphenidate)
and salts of these compounds;

preparations intended for medicinal use containing ethylmorphine, methylmorphine (codeine), beta-morpholinoethylmorphine [morpholinylethylmorphine or pholcodine], 4-dimethylamino-3-methyl-1,2-diphenyl-2-propionoxybutane [propoxyphene] or their salts;
13. galenical preparations incompletely purified.

Article 3

Diacetylmorphine [heroin] and ... be imported into Sweden.

Other substances specified in article 1 A may be imported into Sweden only by a person approved by the National Board of Health as an importer thereof, with prior permission of the Board. This provision shall also apply to preparations specified in article 1 A, sub-paragraph 12, containing ethylmorphine, methylmorphine (codeine), beta-morpholinoethylmorphine [morpholinylethylmorphine or pholcodine], 4-dimethylamino-3-methyl-1,2-diphenyl-2-propionoxybutane (propoxyphene) or their salts, but no other medically active component.

Importation of Customs office at Trälleborg.

The Board of Health has medical opium.

Article 12

Any person unlawfully importing or exporting a substance referred to in article 1 A or B or in article 3, second paragraph, second sentence, or attempting to do so; or

manufacturing any of the substances referred to in article 1 A in contravention of article 6, first and third paragraphs; or

infringing the provisions of article 7, first or second paragraph; or

any medical practitioner, veterinary surgeon or dentist prescribing as a medicament a substance referred to in article 1 A contrary to the relevant provisions of law; or

any person contravening or attempting to contravene the provisions of article 9, first paragraph, otherwise than by unlawful exportation; or

carrying on trade or manufacture contrary to article 10

shall be punished by a per diem fine of not less than twenty-five days, or by imprisonment for not more than six months. Goods in respect of which an offence was committed, together with their containers and wrapping, shall be declared forfeited.

Any person infringing the provisions of article 8 or the stipulations or regulations prescribed by the Board of Health pursuant to article 3, fourth or sixth paragraph, to article 4, second paragraph, to article 6, second paragraph, or to article 8 shall be punished by a per diem fine of not less than ten crowns and not more than three hundred crowns where the offence is not punishable under an earlier provision of the present article or under the Act concerning penalties imposable for illicit import of goods.

Article 13

Where goods which may be presumed to be forfeited are seized in accordance with this Order, the chief investigator or prosecutor shall forthwith notify the Board of Health thereof.

Goods ordered to be forfeited as the Board of Health shall prescribe.

If a person to whom such substances are sold is failing declared forfeited.

Article 14

It is the duty of the Court of Law immediately to inform the Board of Health of the content of any judgment pronounced by the Court in proceedings concerning liability for an offence against the provisions of the present Order or otherwise for a criminal act involving substances or preparations referred to in this Order.

This Order shall enter into force on 1 January 1961.
