TAKROURI

Decree of 27 October 1955 (10 Rabia I 1375) amending the Decree of 23 April 1953 (8 Shaabane 1372)¹, prohibiting the cultivation and use of Takrouri /Cannabis/2)

Praise be to God:

We, Mohamed Lamine Pacha Bey, Possesseur of the Kingdom of Tunis,

Having regard to

The Decree of 23 April 1953 (8 Shaabane 1372) prohibiting the cultivation and use of Takrouri,

The opinion of our Minister of Finance,

On the proposal of our Prime Minister, President of the Council,

HEREBY DECREE

Article 1. -

The first and second paragraphs of article 13 of the above-mentioned Decree of 23 April 1953 (8 Shaabane 1372) are annulled and replaced by the following provisions:

"Article 13, first and second paragraphs (new): As a transitional measure, the provisions contained in the Decree of 11 April 1927 (9 Chaoual 1345) concerning the manufacture of, trade in, possession and sale of Takrouri shall apply until the stocks held by the Administration are exhausted, and in any event not later than 31 December 1955. The provisions of article 18 of the Decree of 11 April 1927 (9 Chaoual 1345) shall also be retained as a transitional measure and until the stocks in the possession of the Monopolies Department are exhausted and in any event not later than 31 December 1955".

Article 2. -

Our Prime Minister, President of the Council, and our Minister of Finance shall be responsible, each in so far as he is concerned, for the application of this Decree.
