PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE CONVENTION OF 13 JULY 1931 FOR LIMITING THE MANUFACTURE AND REGULATING THE DISTRIBUTION OF NARCOTIC DRUGS, AS AMENDED BY THE PROTOCOL OF 11 DECEMBER 1946

NOTE BY THE SECRETARY-GENERAL -- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative text.

THE DANGEROUS DRUGS DECREE

The Dangerous Drugs Order, 1957.

In exercise of the powers vested in him by section 2 A of the Dangerous Drugs Decree, and otherwise, the Comp. 64. Resident in Council is pleased to make and hereby makes the following Order:-

- 1. This Order may be cited as the Dangerous Drugs Order, 1957.
- The drugs set out in the Schedule hereto are hereby declared to be dangerous drugs within the provisions of the Dangerous Drugs Decree.
- 3. The definition of the expression "dangerous drugs" in section 2 of the Dangerous Drugs Decree is hereby amended by the addition thereto of the drugs set forth in the Schedule hereto.
- 4. The schedule to the Dangerous Drugs Order, 1956 1) shall have effect as if for paragraph six thereof the following paragraph were substituted:-

"Diethylthiambutene²⁾, its salts and any preparation, admixture, extract or other substance containing any proportion of diethylthiambutene.'

SCHEDULE

1, 3-dimethy1-4-pheny1-4-propionoxyhexamethyleneimine /Proheptazine/, its salts and any preparation, admixture, extract or other substance containing any proportion of 1, 3-dimethyl-4-phenyl-4-propionoxyhexamethyleneimine.

3-hydroxy-N-phenethylmorphinan /Phenomorphan/, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-hydroxy-N-phenethylmorphinan.

4-morpholino-2, 2-diphenyl ethyl butyrate / Dioxaphetyl Butyrate / its salts and any preparation, admixture, extract or other substance containing any proportion of 4-morpholino-2, 2-diphenyl ethyl butyrate.

4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxybutane/Propoxyphene/, its salts and any preparation, admixture, extract or other substance containing any proportion of 4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxybutane.
