APPLICATIONS AND RE-APPLICATIONS FOR CONSULTATIVE STATUS

Report of the Council Committee on Non-Governmental Organizations

Meetings of the Council Committee on Non-Governmental Organizations were held at Headquarters on 19 February 1952 under the acting chairmanship of Mr. C.A.G. Meade (United Kingdom), to consider documents E/C.2/R.15, E/C.2/R.15/Corr.1 (English only), E/C.2/R.15/Corr.2, E/C.2/R.15/Add.1, E/C.2/R.15/Add.2 and E/C.2/R.15/Add.3. The summary records of these meetings are contained in documents E/C.2/SR.123 and E/C.2/SR.124 (Restricted).

The Committee, acting in accordance with paragraph 35(a) of Council resolution 288 B (X) of 27 February 1950, recommends that the Council adopt the following draft resolution:

"The Economic and Social Council,

"Having considered the report of its Committee on Non-Governmental Organizations (E/2368),

"1. <u>Decides</u> that the following organizations shall be placed in category B:

Inter-American Press Association

International Society of Social Defence

International Union for Inland Navigation

Pan-Pacific Women's Association;

"2. <u>Decides</u> that the following organizations at present on the register of non-governmental organizations referred to in paragraph 17

of Council resolution 288 B (X) shall be transferred to category B: Confédération internationale du crédit populaire International Federation of Journalists International Movement for a Brotherly Union of Races and Peoples International Union of Producers and Distributors of Electric Power;

"3. <u>Requests</u> the Secretary-General to place the following organizations on the register of non-governmental organizations referred to in paragraph 17 of Council resolution 288 B (X):

Centre of International Relationships for Wholesale Trade Federation of International Furniture Removers International Confederation of Professional and Intellectual Workers

World Calendar Association, International, The

"4. <u>Requests</u> the Council Committee on Non-Governmental Organizations, at the seventeenth session of the Council, to reconsider the requests for reclassification from the register to category B of the following organizations:

International Federation of Free Journalists World Federation of Catholic Young Women and Girls

"5. (a) Notes that the International Federation of Unions of Employees in Public and Civil Services and the International Transport Workers' Federation are both prepared to give up their consultative status category B and carry on their consultative relationship with the Economic and Social Council through the International Confederation of Free Trade Unions; and, therefore, "(b) <u>Decides</u> to withdraw consultative status category B from these two organizations."

ANNEX I

ORGANIZATIONS NOT RECOMMENDED FOR STATUS

The Council Committee on Non-Governmental Organizations decided not to recommend the granting of category A consultative status to the following two organizations:

Women's International Democratic Federation

World Federation of Democratic Youth

The Committee took note of the fact that the Women's International Democratic Federation is already in category B consultative status and that the World Federation of Democratic Youth is already on the register of non-governmental organizations referred to in paragraph 17 of Council resolution 288 B (X).

The Committee decided not to recommend the granting of consultative status to the following two organizations:

International Association for the Encouragement of Youth Exchanges International Automotive Institute

In connexion with the application of the last organization, the Committee had before it resolution 9 of the Transport and Communications Commission, adopted at its sixth session (document E/2363).
