Letter dated 4 August 2017 from the Permanent Representative of the Sudan to the United Nations addressed to the President of the Security Council

I have the honour to transmit herewith a chart detailing the violations of the ceasefire by the Sudan People's Liberation Army-North (SPLA-N) in Blue Nile State and South Kordofan State, during June 2017, as well as the violations of the Sudan Liberation Army-Abdul Wahid (SLA-AW) in Central Darfur State (see annex).

I should be grateful if the present letter and its annex would be circulated as a document of the Security Council.

	<i>Date</i>	<i>State</i>	<i>Particulars of the violation</i>
1.	1 June 2017	South Kordofan	Four Sudan People's Liberation Army-North (SPLA-N) rebels attacked a herder and looted his cattle near the Kanjar area 9 km north-west of Dilling. The perpetrators came from Delib a SPLA-N camp and withdrew towards it.
2.	2 June 2017	Blue Nile	A force of SPLA-N rebels coming from Bulbulari area, looted 200 head of sheep and goats from nomads in the Talata Boyot area 4 km south-west of Daim Saad. The perpetrators withdrew towards the Bulbulari area.
3.	5 June 2017	South Kordofan	A force of SPLA-N rebels coming from the Kujoria area attacked the herders in the Gardod Sulaiman area, 35 km east of Elsunut, killing four herdsmen and injuring two.
4.	8 June 2017	South Kordofan	Seven SPLA-N rebels coming from the Abi area attacked the Aljami Mine and looted some belongings of the miners.
5.	11 June 2017	Blue Nile	A force of SPLA-N rebels detained three miners and looted their belongings. They also opened fire on a vehicle of the Ministry of Health bearing a United Nations Children's Fund (UNICEF) logo, between Dairang and Fadamiya, 50 km south of El Damazin. Two employees of the Ministry were injured. The attackers were chased by the security forces, who liberated one miner and killed one of the SPLA-N rebels.
6.	17 June 2017	Central Darfur	Four Sudan Liberation Army-Abdul Wahid (SLA-AW) rebels moved furtively into Naio village, west of Rockero, and injured a civilian in his house, through use of firearms.
7.	18 June 2017	Central Darfur	A force of SLA-AW rebels tried to loot cattle in the area west of Jebel Wisa, 3 km south-east of Galol, and injured one person.
8.	20 June 2017	South Kordofan	Four SPLA-N rebels moved furtively into the Tabaldiya area trying to loot cattle. They were repelled by the security forces in the area.
9.	21 June 2017	South Kordofan	A force of SPLA-N rebels looted 10 head of cattle in the Khor Shatta area. The security forces in the area chased them and exchanged fire with them. The perpetrators escaped and the cattle were restored.
10.	21 June 2017	South Kordofan	A force of SPLA-N rebels attacked a convoy of the Sudan Armed Forces, in an area located 15 km south of Dilling, with guns and a rocket-propelled grenade.
11.	21 June 2017	South Kordofan	A force of SPLA-N rebels looted 200 head of cattle and 50 head of goats in an area east of Kailak town. They moved towards the Korongo Abdalla area.
12.	28 June 2017	Blue Nile	A force of SPLA-N rebels attacked herders in the area 3 km east of the Bulang area. They were chased by the security forces. They moved towards Jebel Badaba, 10 km east of Dairang.
13.	28 June 2017	Blue Nile	Four SPLA-N rebels looted 120 heads of cattle from the Aradeek area, 10 km south-east of the Musfa area. They were chased by the security forces and withdrew towards Jebel Kudum, 10 km east of Bulang.

<i>Date</i>	<i>State</i>	<i>Particulars of the violation</i>
14. 29 June 2017	Blue Nile	A force from SPLA-N attacked fellalla nomads coming from the Republic of South Sudan in the area between Ghabat Zarzora and Jaman Alghanam in the Republic of South Sudan. They looted 100 head of cattle from them.
