
Excellency,

We ask for your kind assistance in transmitting the enclosed joint communiqué, which we signed on behalf of our respective Governments, to all Member States of the United Nations for their information.



CONCERNING  
THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

The Republic of The Gambia and the Republic of Cyprus,

Desiring to promote and strengthen ties of friendship and cooperation between their countries on the basis of equality, mutual respect of each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of each other,

Guided by the principles and purposes of the United Nations Charter, as well as the Vienna Convention on Diplomatic Relations of 1961, and the Vienna Convention on Consular Relations of 1963,

Have decided to establish relations at the ambassadorial level, as of the date of the signing of this Joint Communiqué.
