
We, therefore, request Your Excellency to distribute to all the States Members of the United Nations the enclosed Joint Communiqué that we have signed on behalf of our respective Governments.

**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE FEDERAL REPUBLIC OF NIGERIA
AND THE REPUBLIC OF PANAMA**

The Government of the Federal Republic of Nigeria and the Government of the Republic of Panama, desirous to strengthen the bonds of friendship and cooperation in the political, economic and cultural fields, based on the principles of mutual respect for the territorial integrity and non intervention in the internal affairs of other States, as well as the norms of international law and the principles of the United Nations Charter, have agreed to establish diplomatic relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations, of April 18, 1961.

The Government of the Federal Republic of Nigeria and the Government of the Republic of Panama express their assurances that the establishment of diplomatic relations in accordance with the national interests of both States will facilitate the strengthening of peace and world cooperation.

Signed in the City of New York, on 12 February 2001, in two copies in the English and Spanish languages, both texts being equally authentic.

COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS
ENTRE LA REPUBLICA DE PANAMA
Y LA REPUBLICA FEDERAL DE NIGERIA

El Gobierno de la República de Panamá y el Gobierno de la República Federal de Nigeria, deseosos de estrechar los vínculos de amistad y cooperación en los campos político, económico y cultural, con base en los principios de mutuo respeto a la integridad territorial y a la no intervención en los asuntos internos de otros Estados, así como a las normas del Derecho Internacional y a los principios de la Carta de las Naciones Unidas, han acordado establecer relaciones diplomáticas, de acuerdo con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961.

El Gobierno de la República de Panamá y el Gobierno de la República Federal de Nigeria manifiestan la seguridad de que el establecimiento de relaciones diplomáticas de conformidad con los intereses nacionales de ambos Estados, facilitará el afianzamiento de la paz y la cooperación mundial.
