

Desirous to strengthen the friendly relations and to develop bilateral cooperation in different fields of concern to both countries,

Having the interest to develop relations between the two countries on the basis of mutual respect for sovereignty, territorial integrity and non-interference into internal affairs,

Confirming their commitment to the objectives and principles of the United Nations in consolidating international peace and security,

Have agreed to establish diplomatic relations at Ambassadorial level.



Han acordado el establecimiento de relaciones diplomáticas, a nivel de Embajadores.


