APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP  
OF SUBSIDIARY BODIES OF THE GENERAL ASSEMBLY

UNITED NATIONS ADMINISTRATIVE TRIBUNAL

Report of the Fifth Committee

Rapporteur: Mr. Mohamed EL BARADEI (United Arab Republic)

1. At its 1372nd meeting, held on 28 October 1970, the Fifth Committee considered a note by the Secretary-General (A/7935) concerning the vacancies which will occur in the membership of the United Nations Administrative Tribunal as a result of the expiration on 31 December 1970 of the terms of office of three of its members.
2. The members of the Fifth Committee had been invited to submit the names of persons who might be recommended to the General Assembly for appointment to the Administrative Tribunal, in accordance with the provisions of article 3, paragraphs 1 and 2, of the Statute of the United Nations Administrative Tribunal (General Assembly resolution 351 A (IV)). Three names were submitted for the consideration of the Committee (see A/C.5/1318).
3. The Fifth Committee voted by secret ballot to decide on its recommendation. The result of the voting was as follows:

Three other persons received one vote each.

4. Mrs. Bastid (France), Mr. Mutuale (Democratic Republic of the Congo) and Mr. Venkataraman (India), having received the required majority, were declared recommended for appointment as members of the United Nations Administrative Tribunal for a further three-year term beginning on 1 January 1971.
